LOCAL GOVERNMENT FINANCE SETTLEMENT 2009-10

- PART A: TOTAL REVENUE FUNDING ALLOCATIONS FOR 2009-10**

1. This Finance Circular provides details of the updated, provisional total funding allocations for each council for next year, 2009-10. It also gives details of the Non-Domestic Rate poundage; as well as the current known redeterminations for 2008-09; and changes to capital grants.
2. The provisional total funding allocations form the basis of the annual consultation between the Scottish Government and COSLA ahead of the Local Government Finance (Scotland) Order 2009, which is due to be debated by the Scottish Parliament in early February 2009. COSLA is invited to respond to these provisional allocations in writing by **12 January 2009**. In submitting any comments, we expect COSLA to inform the Scottish Government of any discrepancies in these distributions.
3. These figures are necessarily provisional and any changes required will be discussed and agreed between the Scottish Government and COSLA and included in the 2009 Order. Accordingly, if a council considers there are any errors or revisions that require to be addressed they should, in the first instance, contact COSLA immediately. Where any changes are agreed, compensation will not be paid to any council that may lose their share of funding as a result.

PART A – TOTAL REVENUE FUNDING ALLOCATIONS FOR 2009-10

5. This Finance Circular sets out the provisional distribution of revenue funding allocations for 2009-10. Finance Circular 6/2007 issued on 13 December 2007 set out the details of the 2007 Spending Review and the total funding available to local government. **Annex A** of this Circular updates the all-Scotland aggregate totals for 2009-10.

6. The explanatory notes contained in **Annex B** explain the basis behind the calculation of the individual council grant allocations. **Annex C** sets out the distribution of the total revenue funding allocation between councils and the allocation of the elements (Revenue Funding, Non-Domestic Rate Income and Ring-fenced Revenue Grants) for each council for 2009-10. The basis behind the grant distribution methodology was explained in Finance Circular 6/2007.

7. The methodology for calculating Loan Charges and support for Public Private Partnership (PPP) projects was set out in Annex E of Finance Circular 1/2008. The total amounts included for loan charge support and PPP support are included in the revenue figures in Annex A.

8. The calculation and effects of the floor calculation, which ensures that all councils continue to benefit from, at least, a minimum year-on-year increase in revenue funding was set out in Annex C of Finance Circular 1/2008.

9. **Annex D** gives a breakdown of the individual council shares of ring-fenced revenue grants.

10. **Annex E** (which will be issued very shortly) will provide a reconciliation of changes to revenue funding that have taken place since Finance Circular 4/2008.

PART B – REDETERMINATIONS OF REVENUE FUNDING FOR 2008-09

11. Councils have indicated that they have found it helpful to have early notification of redeterminations of revenue funding for 2008-09. **Annex F** provides the most up-to-date information available and is the current status of the list that has been provided to COSLA throughout the year. The final allocations for 2008-09 and any previous years will be included in the 2009 Order.

PART C – TOTAL CAPITAL FUNDING ALLOCATIONS FOR 2009-10

12. This Finance Circular sets out the provisional distribution of capital allocations for 2009-10, and provides a reconciliation back to the provisional capital allocations for 2008-2010 as set out in Finance Circular 1/2008.

13. **Annex G** provides a summary of the total Capital Allocations for 2009-10. It provides distribution details for the General Capital Grant, Supported Borrowing and Specific Capital Grants by local authority. Any capital allocations which are undistributed are identified as such.

14. The distribution and methodology of new in year Supported Borrowing was set out at Annex E to Circular 1/2008. There are no changes to allocations as set out in that Circular

15. **Annex H** provides details of the grants that make up the total Specific Capital Grants allocation and their distribution to local authorities. Some grants have still to be distributed, and for these only the total value of the grant is provided.

16. **Annex I** provides a reconciliation of the changes to the total Capital Allocation for 2009-10 from Circular 1/2008 to this circular.

17. **Annex J** provides a reconciliation of the changes to the total Capital Allocation for 2008-09 from Circular 1/2008 to this circular.

PART D – NON-DOMESTIC RATES FOR 2009-10

18. The 2009-10 Non-Domestic Rate Income poundage rate has been set today by the Scottish Government at 48.1 pence, with a supplement of 0.4 pence for rateable values in excess of £29,000.

19. The Distributable Amount of Non-Domestic Rate Income for 2009-10 has been set at £2,127.100 million. This figure uses the latest forecast of net income from non-domestic rates in 2009-10 and will also draw on council estimates of the amounts they will contribute to the Pool from non-domestic rate in 2008-09. Included in the estimated figure is a calculation of gross income, expected losses from appeals and estimated expenditure on mandatory and other reliefs as well as write-offs and provision of bad debt.

2010-11 Provisional Figures

20. The provisional figures for 2010-11 have not been updated in this Circular. One of the implications of the Pre-Budget Report was an additional £5 billion in efficiency savings target for 2010-11. UK Departmental budgets will be reduced in the next budget to reflect these new targets. HM Treasury will apply a consequential reduction in the Scottish budget, but the final figures have not yet been confirmed. Having consulted COSLA, we propose to hold back updating figures for 2010-11 until after final confirmation has been received from HM Treasury and the implications can be discussed further with partners.

Questions relating to this Circular

21. As agreed with COSLA, general enquiries about the figures contained in this Circular should be directed to COSLA in the first instance. The Scottish Government has given an undertaking to COSLA to respond to all enquiries as quickly as possible and will provide further general information where appropriate.

The explanation of each of the columns in the tables in Annex C is as follows:

Column 1 – represents the updated ongoing service provision and includes the following combined information: (i) the updated Grant Aided Expenditure (GAE) assessments; (ii) the revised Special Islands Needs Allowance (SINA); (iii) each council's individual share of the ongoing revenue grants which have been rolled up into the core local government finance settlement; and (iv) the extra £120.5 million general revenue funding originally provided in 2007-08; plus the Quality of Life and loan charges and SINA headroom amounts.

Column 2 – is the total, non-ring-fenced uplift in provision resulting from Spending Review 2007 and allocated pro-rata to each council's share of GAE. This includes the £70 million for freezing 2008-09 council tax at 2007-08 levels.

Column 3 – represents the updated share of the loan charges support for outstanding and new debt and the same level of ongoing PPP level playing field support.

Column 4 – is the floor adjustment which has been calculated as in previous years by excluding PPP level playing field support. The amount of the ongoing revenue grants which have been rolled up into the core local government finance settlement were excluded on the grounds of stability.

Column 5 – this is the net revenue expenditure recognised by the Scottish Government and represents the sum of columns 1 to 4.

Column 6 – is the assumption of the amount of Total Estimated Expenditure to be funded from the council tax. Any changes are as a result of buoyancy or projected numbers of properties.

Column 7 – is each council's share of the ongoing ring-fenced revenue grants.

Column 8 – is each council's share of the estimated non-domestic rate income which has been distributed on the basis of population.

Column 9 – is the balance of funding provided by means of general revenue funding and is calculated by deducting columns 6, 7 and 8 from the Total Estimated Expenditure in column 5.

Column 10 – represents the total revenue funding available to each council in 2009-10 **net** of any additional funding if council tax levels are frozen.

Column 11 – gives each council's share of the £70 million being made available if their council tax levels are frozen in 2009-10.

Column 12 – represents the total revenue funding available to each council in 2009-10 assuming their council tax levels are frozen.
