- 1. LOCAL GOVERNMENT FINANCE (SCOTLAND) ORDER 2018 - SETTLEMENT FOR 2018-19 AND REDETERMINATIONS FOR 2017-18**
- 2. LOCAL GOVERNMENT CAPITAL ALLOCATIONS 2018-19**
- 3. NON DOMESTIC RATES FOR 2018-19**

1. The Scottish Parliament today debated and approved the Local Government Finance (Scotland) Order 2018. This Order provides the statutory authority to pay the General Revenue Grant (GRG) for 2018-19. The Order also confirms the changes made to amounts payable to each authority for 2017-18 since the 2017 Order.

2. This Circular provides a summary of the 2018-19 figures (and the revised Revenue allocations for 2017-18) contained in the 2018 Order, which have been revised from those contained in Local Government Finance Circular No. 5/2017.

3. The Cabinet Secretary for Finance and the Constitution wrote to all 32 local authorities on 14 December and 31 January providing details of the proposed settlement, including additional resources following Stage 1 of the Budget Bill. The Scottish Government requires local authorities to deliver on the full package of agreed measures as set out in the offer letters, including the shared priorities which will improve outcomes for local people.

4. The total overall funding package for 2018-19 includes:

- an additional £159.5 million of General Revenue Grant added at Stage 1 of the Budget Bill. It should be noted that of this total £125 million is included in the 2018-19 funding allocations with the balance of £34.5 million being paid as a redetermination of the 2017-18 funding and will be paid on 28 March 2018;
- an additional £10.5 million to Shetland and Orkney Island Councils in support for inter-island ferry services;
- baselining from 2018-19 of the £130 million additional revenue investment announced at Stage 1 of the Budget Bill for 2017-18;

- £52.2 million revenue and £150 million capital to deliver on our joint agreed ambitious programme for the expansion of Early Years Education and Childcare provision. This is in addition to the £11 million of revenue which has been added to support the initial expansion of Early Years set out in the 2014 Act provisions;
- an additional £24 million to cover the additional full year cost of the teachers' pay offer for 2017-18;
- a continued funding package of £88 million, made up of £51 million to maintain teacher numbers and £37 million to support the Teacher Induction Scheme. Local authorities will continue to be required to maintain an overall pupil:teacher ratio of 13.7 and secure places for all probationers who require one under the Teacher Induction Scheme;
- an additional £66 million to support additional investment in social care in recognition of a range of pressures local authorities are facing, including support for the implementation of the Carers (Scotland) Act 2016, maintaining our joint commitment to the Living Wage (including our agreement to now extend it to cover sleepovers following the further work we have undertaken) and an increase in the Free Personal and Nursing Care payments;
- maintenance of the £355 million baseline transfer from NHS Boards to Integration Authorities in support for health and social care; and
- the continued flexibility to increase Council Tax by up to 3% which could generate an additional £77 million.

5. In addition, but outwith the local government finance settlement, a further £24.1 million of recurring baselined funding will be allocated to support the expansion of Early Years Education and Childcare initiative and a £13.6 million top up from the Offender Services budget will be allocated in support of the Criminal Justice Social Work funding within the settlement.

6. The various parts and Annexes to this Circular, listed below, provide more detail behind the calculations.

## **Part A: Local Government Finance Settlement – Revenue: 2018-19 and changes in 2017-18**

7. In 2018-19 the Local Government Settlement provides revenue grants totalling £9,779.9 million. This is made up of General Revenue Grant totalling £6,870.250, Non Domestic Rate Income of £2,636 million, and Specific Grants totalling £273.650 million. This Finance Circular sets out the distribution of revenue funding allocations for 2018-19 and 2017-18. **Annex A** of this Circular sets out the all-Scotland aggregate totals for 2017-19 and the changes since Finance Circulars 1/2017 and 5/2017 respectively.

8. **Annexes B and C** set out the distribution of the total revenue funding allocation between councils and the allocation of the different elements (General Revenue Funding, Non-Domestic Rate Income, and Ring-Fenced Revenue Grants) for each council for 2018-19 and 2017-18 respectively. The basis behind the grant distribution methodology as explained in Finance Circular 6/2007 has been retained as agreed with COSLA, and additional funding to deliver the Scottish Government's 85% floor is included at the end of this process. The explanatory notes contained in **Annex D** explain the basis behind the calculation of the individual council grant allocations for 2018-19.

9. **Annex E** provides a breakdown of additional distributable revenue allocations for 2018-19 since Finance Circular 5/2017 and **Annex F** gives a breakdown of the individual council shares of all the Ring-Fenced grants for 2018-19. Annex F also includes a breakdown of the additional funding outwith the core settlement as described in paragraph 5 above.

10. The calculation and effects of the main floor adjustment for 2018-19, which provided councils with a maximum decrease in funding of -0.4%, is set out in **Annex G** of this Circular. The setting of the floor at this level reflects requests from local government to restrict the range of annual changes in individual local authority allocations. This information updates the previous calculations set out in Finance Circular 5/2017.

11. The changes to the 2017-18 GRG figures since Local Government Finance Circular 1/2017 are set out in **Annex H**.

12. **Annex I** explains all the changes which result in the column titled 2008-2019 Changes within the 2018-19 settlement since Finance Circular 5/2017.

## **Part B: Local Government Finance Settlement – Capital Grants 2018-19**

13. In 2018-19 the Local Government Settlement provides capital grants totalling £876.364 million. This is made up of General Capital Grant totalling £598.282 million and Specific Grants totalling £278.082 million.

14. **Annex J** sets out the distribution of the Settlement for capital grants per local authority for 2018-19.

15. **Annex K** sets out the allocations within the General Capital Grant for flood schemes for 2018-19.

16. **Annex L** summarises the Local Government Finance Settlement for 2018-19.

## **Part C: Non-Domestic Rates for 2018-19 and Business Rates Incentivisation Scheme**

17. The Distributable Amount of Non-Domestic Rate Income for 2018-19 is confirmed as £2,636 million.

18. The following eight pieces of non-domestic rates legislation (accessible online at [www.legislation.gov.uk](http://www.legislation.gov.uk)) come into effect on 1 April 2018.

**18.1. The Non-Domestic Rate (Scotland) Order 2018.**

This Order sets the non-domestic rate poundage of 48 pence in Scotland for 2018-19.

**18.2. The Non-Domestic Rates (Levying) (Scotland) Regulations 2018.**

These regulations make provision for a poundage supplement (referred to as the Large Business Supplement) in 2018-19 of 2.6 pence on properties with a rateable value in excess of £51,000; and for reductions in non-domestic rates as a result of the Small Business Bonus Scheme (SBBS) for 2018-19.

**18.3. The Non-Domestic Rates (Day Nursery Relief) (Scotland) Regulations 2018.** <http://www.legislation.gov.uk/ssi/2018/65/contents/made>

Provides up to 100% relief for premises used wholly or mainly as day nurseries.

**18.4. The Non-Domestic Rates (Telecommunication Installations) (Scotland) Amendment Regulations 2018**

Updates the pilot relief for telecoms masts in 3 designated rural areas (maps) in the Non-Domestic Rates (Telecommunication Installations) (Scotland) Regulations 2016 until 31 March 2029 and adds 17 new eligible sites.

**18.5. The Non-Domestic Rates (Transitional Relief) Amendment (Scotland) Regulations 2018**

Extends transition relief arrangements into 2018-19 for hospitality properties and Aberdeen City/Shire offices with an additional 12.5% real terms relief. Hospitality properties must have a rateable value under £1.5 million to qualify. De minimis applies to this relief. Relief does not continue for former relief, splits or hydro premises.

**18.6. The Non-Domestic Rates (Renewable Energy Generation Relief) (Scotland) Amendment Regulations 2018**

Continues relief for hydro generation sites and increases the relief for Hydro generation where the rateable value is under £5 million to 60%. Relief for new builds ends.

**18.7. The Non-Domestic Rating (Unoccupied Property) (Scotland) Regulations 2018**

This relief expands Fresh Start relief by reducing eligibility criteria to 6 months unoccupied prior to new occupation, doubles the relief to 100% for the first 12 months of new occupation and extends the relief to all categories of property with rateable value under £65,000. New Start relief ends, except for properties currently in receipt of relief.

## **18.8. The Non-Domestic Rates (New and Improved Properties) (Scotland) Regulations 2018**

Provides 100% rates relief for certain new-build properties until a year after first occupation. Additionally the Regulations ensure that no increase in rates is payable for a year in respect of certain property improvements.

19. As set out above, for 2018-19 the Non Domestic Rate poundage is set at 48p and the Large Business Supplement at 2.6p for property with a rateable value over £51,000.

20. A further Local Government Finance Circular providing updates on the Business Rates Incentivisation Scheme will be issued as soon as possible.

## EXPLANATORY NOTES ON THE REVENUE DISTRIBUTION

## ANNEX D

The explanation of each of the columns within the tables at Annex B is as follows:

**Column 1** – represents the updated on-going service provision and includes the following combined information: (i) the updated Grant Aided Expenditure (GAE) assessments; (ii) the revised Special Islands Needs Allowance (SINA); (iii) each council's individual share of the on-going revenue grants which have been rolled up into the core local government finance settlement; (iv) each council's share of all the baselined redeterminations since Spending Review 2007; (v) the shares of the £630 million for the council tax freeze over the period 2008-17 and (vi) new 2018-19 funding.

**Column 2** – is the new combined total, non-ring-fenced, changes in general provision resulting from Spending Reviews 2007, 2010, 2011, 2013, 2015 and budget revision for 2016 and 2017 allocated pro-rata to each council's share of GAE plus SINA. This excludes the £34.5 million resulting from Stage 1 of the Budget Bill which is included in column 2 of Annex C. Footnote in Annex A refers.

**Column 3** – represents the updated share of the loan charges support for outstanding debt and the same level of on-going PPP level playing field support. The methodology for calculating Loan Charge Support (LCS) and support for Public Private Partnership (PPP) projects (level playing field projects only (LPFS) is set out on Annex H of Finance Circular 2/2011.

**Column 4** – is the main floor adjustment which has been calculated as in previous years by excluding PPP level playing field support. The amount of the on-going revenue grants which have been rolled up into the core local government finance settlement and the council tax freeze amount, were also excluded on the grounds of stability.

**Column 5** – this is the net revenue expenditure recognised by the Scottish Government and represents the sum of columns 1 to 4.

**Column 6** – is the assumption of the amount of Total Estimated Expenditure to be funded from the council tax. Any changes are as a result of buoyancy or projected numbers of properties, as well as the estimated additional council tax income to be collected and retained by each local authority as a result of the changes to bands E to H.

**Column 7** – is each council's share of the on-going Ring-Fenced Grants for Gaelic and the Pupil Equity Fund.

**Column 8** – is each council's share of the estimated non-domestic rate income which has been distributed proportionately on the basis of council's 2017-18 mid-year income.

**Column 9** – is the balance of funding provided by means of general revenue funding and is calculated by deducting columns 6, 7 and 8 from the Total Estimated Expenditure in column 5.

**Column 10** – represents the total revenue funding available to each council in 2018-19.

**Column 11** – is the 85% floor adjustment which has been calculated to meet the Scottish Government's commitment to ensure that no Local Authority receives less than 85% of the Scottish average per head in terms of revenue support.

**Columns 12** - is the revised total funding including all the changes and the 85% funding floor adjustments.
