COVID-19 BUSINESS SUPPORT EXPERIMENTAL STATISTICS: STRATEGIC FRAMEWORK BUSINESS FUND

Summary

This publication provides experimental statistics for the Strategic Framework Business Fund (SFBF), which was set up to support businesses in Scotland that are required by law to close or to significantly change their operations due to COVID-19 restrictions from 2 November 2020. Support is available under two funds as follows:

- temporary closure grant of £2,000 or £3,000 (depending on rateable value for the premises from which businesses operate) if it is required to close by law; or,
- business restrictions grant of £1,400 or £2,100 (depending on rateable value for the premises from which businesses operate) if it can remain open but is specifically required to modify its operations by law, for example having to close earlier than normal.

Awards for the SFBF are paid over 4 periods.

As at 28 December 2020 23,254 applications for business support had been made to the SFBF over two payment periods from 2 November 2020 to 28 December 2020.

At the national level, about 58% of applications were accepted. About 21% of applications were rejected, and 1% was either referred or deferred. The remaining 20% was still awaiting processing.

Where reasons for rejections have been recorded,¹ the most common reason was that the applicant was in an ineligible sector. About 81% of applications rejected (3,020 applications) fell into this category.

The total amount budgeted for the SFBF for the period from 2 November 2020 to 28 December 2020 is £66,020,000. Of this amount, £31,403,701 or 47.6% of the budget has so far been disbursed to businesses. This was made against 13,462 accepted applications, which account for a total of 23,398 awards over the period.

For the Temporary Closure Fund, disbursements were made against a total of 17,719 applications amounting to a total of £21,761,625.72. This is an average of £1,228.15 per award. For the Business Restrictions fund, a total of 5,679 awards were made giving a total of £9,642,075 in awards. This is an average of £1,698 per award.

For smaller premises with a RV < £51K, a total of 21,497 awards were made for a total of £26,933,589 in awards. This is equivalent to an average of £1,253 per award. For larger premises with a RV of > £51K, a total of 1,901 awards were made for a total of £4,470,111 in awards. This is an average of £2,351 per award.

As of 28 December 2020, the total value of grants disbursed for the four week period from 2 November £14,382,104. The comparable figure for the four week period from 31 November was £11,979,896. For some awards the period for which disbursement relates to was not recorded for a total of £5,041,700.

1. Introduction and background

All businesses in Scotland that that are required by law to close or to significantly change their operations due to COVID-19 restrictions from 2 November 2020 are eligible to apply for grant funding available through the Scottish Government Strategic Framework Business Fund (SFBF). A business can apply for a:

- temporary closure grant of £2,000 or £3,000 (depending on rateable value for the premises from which businesses operate) if it is required to close by law; or,
- business restrictions grant of £1,400 or £2,100 (depending on rateable value for the premises from which businesses operate) if it can remain open but is specifically required to modify its operations by law, for example having to close earlier than normal. This does not include where a demand for products or services has been reduced because of the pandemic.

Grants are paid every 4 weeks in arrears as long as restrictions last, with the earliest claims covering the four week period from 2 November 2020.

The support provided through the SFBF is separate from that made available to businesses through the Coronavirus (COVID-19) Restrictions Fund, which supported businesses impacted by local COVID-19 restrictions from 9 October until 1 November. Applications for that funding closed on 3 November 2020, and statistics are reported using a separate publication.

2. Strategic Framework Business Fund applications

2.1 Application status

This section describes application status, and figure quoted in this section relate to applications rather than awards. Table 1 to table 4 show information from both payment periods, from 2 November to 28 December.

As at 28 December 2020 23,254 applications for business support had been made to the SFBF over two payment periods from 2 November 2020 to 28 December 2020.

Across Scotland, 13,462 of these applications to the SFBF had been accepted as at 28 December 2020. Each of the application can have multiple awards over time, where a business continues to be affected by the public health measures that entitle to continued support. The applications accepted represent about 58% of all applications received.

The number of applications awaiting processing as at 28 December was 4,618. This is equivalent to 20% of all applications to the SFBF since it was launched, an improvement from 36% recorded in the experimental statistics published on the 18 December 2020. This reflects local authorities having had more time to process initial applications.

One area of interest is how quickly applications are being processed. Looking back at those applications made in the initial period from 2 November 2020, of the 6,884 applications received, only 221 were still to be processed as at 28 December 2020. This is equivalent to 3% of applications received for this period.

At the national level, about 21% of applications were rejected, and 1% was either referred of deferred.

Applications may be rejected, referred or deferred for several reasons including multiple applications made by a single business, not meeting the eligibility criteria or requiring additional information to be provided. Were reasons for rejections have been recorded,² the most common reason was that the applicant was in an ineligible sector. About 81% of applications rejected (3,020 applications) fell into this category. Table 2 summarises the reasons for rejecting applications for those businesses where information has been recorded.



3. Disbursement of support

This section relates to awards to business premises. Table 5 to table 8 show information from both payment periods, from 2 November to 28 December. Table 9 shows awards by month.

The total amount budgeted for SFBF for the period from 2 November 2020 is £66,020,000. Of this amount, £31,403,701 or 47.6% of the budget has so far been disbursed to businesses. This was made against 13,462 accepted applications, which account for a total of 23,398 awards over the period.

3.1 Local Authority Level Spend

At the Local Authority level disbursement ranged from as high as 110% (Na h-Eileanan Siar showing more support being disbursed than was budgeted) and 22% (Aberdeen City). The average total disbursement per Local Authority was £606,813 and the median was £980,413.

3.1.1 LA level disbursements by support type

For the Temporary Closure fund, disbursements were made against a total of 17,719 applications amounting to a total of £21,761,625.72. This is an average of £1,228.15 per award. The average spend across LAs was £680,051 for the Temporary Closure Fund.

For the Business Restrictions fund, a total of 5,679 awards were made giving a total of £9,642,075 in awards. This is an average of £1,698 per award. The average spend across LAs was £301,315 for the Business Restrictions Fund.

The total number of awards (23,398) exceeds the number of applications approved, because over the two periods of restriction covered by the statistics some applications will have more than one award. This is because a premises has continued to be affected by measures in a way that entitles it to continued support.

3.1.2 Local Authority Spend by Rateable Value

For smaller premises with a RV < £51K, a total of 21,497 awards were made for a total of £26,933,589 in awards This is equivalent to an average of £1,253 per award. The average amount each LA dispersed to premises with RV < £51k was £841,675.

For larger business with RV > £51K, a total of 1,901 awards were made for a total of £4,470,111 in awards,. This gives an average of £2,351 per award.

As of 28 December 2020, the total value of grants disbursed for the four week period from 2 November £14,382,104. The comparable figure for the four week period from 31 November was £11,979,896. The period for which disbursement relates to was not recorded for a total of £5,041,700.

4. Methodology

4.1 Data collection

Each Local Authority in Scotland has recorded information relating to applications received for the Strategic Framework Business Fund. Local Authorities in Scotland are the owners of these data.

Scottish Government asked all Local Authorities in Scotland to provide the following information, via a standardised excel template, for publication purposes;

- Number of applications received
- Number of applications awaiting processing
- Number of applications rejected
- Number of applications referred or deferred
- Number of applications accepted
- Number of grants awarded
- Value of grants awarded

Scottish Government asked that award information be provided for both funds and within each fund for the information to be further split by rateable value (less than/equal to £51k and over £51k)

For the first time in this collection LAs were asked to provide application level data:

- For each premises in receipt of a grant or whose application is held:
 - o Name of account holder (payee name) in receipt of grant
 - Company registration (if held)
 - Business purpose (free text from application form, if available and reportable)
 - Rateable value (under or over £51k)
 - o Eligibility under each tier
 - Date of application (for each premises award application⁶)
 - Application status (for each premises award application ⁶)
 - o Date of decision (for each premises award application ⁶)
 - Reason for Rejection (if applicable for each premises award⁶) to include:
 - Multiple premises limit exceeded
 - Not enough information supplied
 - Ineligible sector
 - Duplicate applications
 - Not trading
 - HQ outside LA
 - Other please specify

⁶ Here the meaning of premises award application is the award that a business applies for in each premises (where the business has multiple premises, when they have only one, it is simply the business application)

- Payment amount in the last 4 week period (for each premises award application ⁶)
- o Total Payments to date (for each premises award application ⁶)

Unfortunately only 23 out of 32 LA were able to do so at this time⁷. We are working with local authorities to provide this data for the next release. For those LA that did submit data at application level, they were asked to split aggregates by the month of application. Four LAs were not able to split data by the month of application and provided cumulative data for the whole period⁸.

The requested information was to cover the period 3 November to 28 December.

4.2 Data reporting

The information received from each Local Authority was amalgamated into a single dataset. This dataset was drawn from the templates received and aimed to create national level figures. There are some caveats to this approach;

- In some returns the stated number of applications received was lower than
 the sum of the application status categories (awaiting processing, rejected,
 referred or deferred and awarded). In these cases, the total number of
 applications has been recalculated to equal this sum.
- In other returns, the total number of applications exceeded the sum of the application status categories (awaiting processing, rejected, referred or deferred and awarded). In these cases it has been assumed that the discrepancy is caused by additional applications 'awaiting processing' and that figure has therefore been updated accordingly.
- Some LAs did not provide all the data required at application level. In particular, information on processing applications and ratable value was missing in some cases.
- As not all LAs provided application level data we were not able to fully split reporting by tranche. Where possible these breakdowns have been provided for the LAs which did.
- Due to the timing of this exercise a reasonably high proportion of applications were still awaiting processing.
- Some Local Authorities did not disaggregate the information by rateable value. Disaggregated information has been calculated and provided wherever possible.
