'NEWBUILDCON' Standard Newbuilding Contract between the Ferguson Marine Engineering Limited (the "Company") and CMAL dated 16 October 2015 as amended on 2 November 2016 for the construction of a Euro Class B Dual Fuel Passenger Ferry with Builder's Hull Number 801 (the "801 Build Contract")

'NEWBUILDCON' Standard Newbuilding Contract between the Company and CMAL dated 16 October 2015 as amended on 2 November 2016 for the construction of a Euro Class B Dual Fuel Passenger Ferry with Builder's Hull Number 802 (the "802 Build Contract") (801 Build Contract and 802 Build Contract together the "Contracts")

I refer to your meeting this morning with Gerry Marshall and also to my letter to you of 3 April 2017.

I understand that at the meeting this morning, you indicated that your recommendation to Transport Scotland is that a final payment of 10% is retained on each of the Contracts and this is the proposal you have been working on.

In my letter to you of 3 April 2017, I thought it was clear that if the request to drop the refund guarantees is not met, then the acceleration of only £14.55m of the final payments under the Contracts is not sufficient in order to relieve the cash pressures on the Company.

I understand Gerry reconfirmed to you this morning, that in the scenario where the refund guarantees remain in place, we require the full amount of the final payments under the Contracts (£24.2m in aggregate) to be accelerated in line with the attached schedule of payments, which I believe has previously been shared with you.

We had previously communicated that we required an initial payment of £7,000,000 by Friday 28th April 2017. It is therefore a matter of extreme urgency that we have your agreement to the attached payment schedule, with the first payment being paid to us by the end of the week.
