## Consultation - Knife Crime

### Knives

Yes Knives *can be* lethal weapons, and *society should not encourage* people to carry them for protection or as a status symbol.

But many ordinary working, often rural, folk **need knives** every day, and the definition of "non-domestic" does not cover this. I use a knife to cut sheep's hooves, cut strings, repair machines, grulloch deer and in many other ways as an angler, shooter and farmer. I need it every day. I would see this as yet another attack on rural life.

Increasing the age from 16 to 18 is pointless. If society continues to treat 16 and 17 year olds as children then of course they will behave like children.

### Swords

The Executive's consultation summary published the **numbers of knife crimes** but did not publish the number of **sword crimes**. Why not? Is it because it is small? Is this a sledgehammer to crack a nut? Whilst on statistics: **how many of these knife murders (average 54 a year) are using domestic knives?** Anyway many people own old swords for decorative, historical, sentimental, family reasons. They should be allowed to do so. The "nanny state" will have to be curtailed soon.

### Overall

I urge the Executive to concentrate on the cause not the symptom. Create a society where fewer people want to be violent, don't just try to address the violence after it starts to manifest itself, by trying to take away the methods. There will always be methods. There will always be weapons of some kind.
