#### LOCAL GOVERNMENT FINANCE SETTLEMENT 2007-08

**SETTLEMENT: 2005-08** 

- 1. This Finance Circular (FC) provides details of the provisional Scottish Executive Aggregate External Finance (AEF) allocations for each local authority for next year. It also gives details of (i) the Non-Domestic Rate poundage and Distributable Amount for 2007-08; (ii) the currently known redeterminations of grant for both the current and next financial year and tidies up the 2005-06 redeterminations; (iii) extra capital grant for 2007-08 and (iv) an update on the revenue and capital grants outwith the core local government finance settlement for the period 2004-08.
- 2. The provisional AEF proposals now announced form the basis for consultation between Scottish Ministers and COSLA ahead of the Local Government Finance (Scotland) Order 2007 which is due to be debated by the Scottish Parliament in early February 2007. COSLA are invited to respond to these provisional allocations in writing by **5 January 2007**. In submitting those comments, we expect COSLA to inform us if there are any discrepancies in the distribution.

### PART A – AGGREGATE EXTERNAL FINANCE (AEF) ALLOCATIONS FOR 2007-08

4. Finance Circular 1/2006, issued on 8 February 2006, set out the revised provisional distribution of AEF for 2007-08.

- 5. **Annex A** of this Circular confirms the revised all-Scotland aggregate totals for 2007-08.
- 6. **Annex B** details the changes to the existing allocations in Annex C of FC 1/2006 as well as details of anticipated additional allocations and transfers. The majority of these have been the subject of separate notification to local authorities.
- 7. **Annex C** sets out the distribution of the revised Distributable AEF between local authorities and the allocation of the three elements of AEF (Revenue Support Grant, Non-Domestic Rate Income and Specific Grants) for each local authority. The revenue grant distribution arrangements for the three year settlement allocations, including population projections, were agreed as a result of Spending Review 2004.
- 8. The calculations outlined in **Annex** C are broadly as follows. Estimated Service Expenditure (ESE) includes an amount for Special Islands Needs Allowance for each appropriate local authority. Added to ESE are allocations for Quality of Life, allowances for Loan Charge Support, Public Private Partnership (PPP) and Level Playing Field Support (LPFS), and the minimum grant floor adjustment (see paragraph 12 below). This produces a Total Estimated Expenditure (TEE) figure for each local authority. AEF totalling £8,715.410 million is then distributed to produce a uniform difference between TEE and AEF per Band D equivalent property across Scotland. Annex C also shows the allocation of the three elements of AEF for each local authority.
- 9. The methodology for calculating Loan Charge and Support for PPP projects is the same as set out in Annex 6 of FC 8/2004. The total amounts included for loan charge support and PPP support are confirmed as £978.000 million in 2007-08.
- 10. In keeping with the move towards simplification agreed previously, the circular focuses on each local authority's total grant allocation. Separate Grant Aided Expenditure (GAE) allocations for individual services are not identified however individual GAEs are available on the Local Government Finance section of the Scottish Executive's <u>website</u>.
- 11. Once the final figures are approved by Parliament, in early February 2007, through the Local Government Finance (Scotland) Order 2007, the associated Circular confirming these final figures will give any further reconciliation details that are necessary.
- 12. To further ensure that all councils continue to benefit from the minimum increases in grant arising from Spending Review 2004, the floor calculation, which remains unaltered, ensures that









each council is provided with a minimum grant increase of at least 1.75 per cent in 2007-08. The calculation for 2007-08 is included at **Annex D**.

- 13. **Annex E** gives a breakdown of individual local authorities' shares of specific grants as used in the calculation of RSG. The changes from FC 1/2006 are explained in Annex B and Annex G. All other lines remain unchanged.
- 14. The balance of Distributable AEF comprises (a) an estimated total of £861.327 million for specific grants (including Police Loan Charges specific grant) and (b) RSG for the year of £5,994.356 million.
- 15. **Annex G** summarises the changes to the individual local authority allocations between FC 1/2006 and this Circular.

#### PART B – NON-DOMESTIC RATES FOR 2007-08

- 16. The 2007-08 Distributable Amount (DA) of Non-Domestic Rate Income (NDRI) has been calculated using the 2007-08 poundage rate of 44.1 pence set by Scottish Ministers on 13 December 2006.
- 17. Taking that into account, Scottish Ministers have decided that the Distributable Amount (DA) of Non-Domestic Rate Income (NDRI) for 2007-08 is £1,859.727 million. The DA of NDRI incorporates a forecast of net income from non-domestic rates in 2007-08. It draws on councils' estimates of the amounts they will contribute to the pool from NDRI in 2006-07. Included in the calculation are gross income, expected losses from appeals, the expected in-year cost of the transitional relief scheme and estimated expenditure on mandatory and other reliefs as well as write-offs and provisions for bad debt. Adjustments are also made for amounts carried over from previous years. **Annex F** shows how the DA was calculated.

## PART C - REDETERMINATIONS OF REVENUE SUPPORT GRANT 2005-08

18. Local authorities have indicated that they have found it helpful to have early notification of the grant redeterminations for both the current and next financial years, 2006-07 and 2007-08, and any previous years. **Annex H** provides the most up-to-date information available and is the current status of the list that the Executive has been providing to COSLA on a monthly basis. The final grant allocations for 2006-07 and prior years will be included in the 2007 Order.

#### PART D - EXTRA CAPITAL GRANT FOR 2007-08

19. An extra, one-off, £61 million of capital grant will be provided to local authorities for 2007-08. This additional support will be tied to an increase in the Efficient Government target on the basis that, at least, an equal amount of efficiency savings are delivered in return and that councils take steps to improve their asset management planning. Asset management is important for both Best Value and Efficient Government. Councils, between them, control capital investment and infrastructure worth almost £21 billion. Effective management of their asset portfolio should be a key component in local government's drive to secure efficiency gains. Improvements in the strategic and operational management of capital assets will have a significant impact on the financial resources available to councils. This additional funding may also allow councils to bring forward additional investment on a spend to save basis (such as renewable energy) that would release









significant savings in the future. Further details are expected to be confirmed early in the new year, including allocations to individual councils.

#### PART E - REVENUE AND CAPITAL GRANTS OUTWITH CORE SETTLEMENT: 2005-08

20. **Annex I** summarises and updates the revenue and capital grants outwith the core local government finance settlement for the period 2005-08 and provides a link to the full details of these grants on the Scottish Executive <u>website</u>. This is an update of the information provided in FC 5/2006. The overall funding position is summarised in the table below:

### CHANGES MADE (OR TO BE MADE) TO THE PREVIOUSLY ANNOUNCED FIGURES

This Annex summarises the changes that have been made to the 2007-08 settlement figures since FC 1/2006 and included in this Circular. It also gives details of significant changes which are currently being finalised and are likely to be included in time for the Local Government Finance Order due to be considered by Parliament early in February 2007.

#### **Additional Money**

### 1. Additional Funding for Local Government/Teachers Pensions

The Minister for Finance and Public Service Reform promised on a number of occasions to look again at the level of the 2007-08 settlement. In keeping with this commitment, the Minister has today announced an additional £140 million in revenue support for 2007-08 in recognition of a number of pressures and future challenges local authorities are facing across the range of services that they deliver. Beyond the broad conditions set out in the Minister's statement to Parliament, this additional funding will be largely unhypothecated, with only £19.5 million set aside for an uplift in Teachers' Pensions provision reflecting increases in employers contributions and has been added to the GAE line for Teachers Pensions. The remaining £120.5 million has been distributed on the basis of authorities' shares of GAE.

### 2. Additional funding for the Pre-School Education Advisory Floor.

Additional funding of £5 million has been made available through the core settlement and was announced in a letter issued by the Scottish Executive Education Department on 10 August 2006 to local authority Education Departments.

## 3. Effect of GAE Distributional Changes on Orkney

Paragraph 5 of Annex B of FC 1/2006 noted that GAE distributional changes adjusted the Support for Airports and Harbours and Civil Protection GAE lines. It was agreed that as Orkney required greater compensation and that it should continue for 2007-08, so Orkney will receive an additional £0.447 million.

#### 4. National Priorities Action Fund

An additional £11.354 million has been allocated through the National Priorities Action Fund Specific Grant, for Curriculum for Excellence, Job Sizing and Parental Involvement.

## 5. Gaelic

An additional £0.4 million has been allocated to the Gaelic Specific Grant.

### Reductions in Total AEF

### **6.** In-Service Training of Teachers (INSET)

Provision for INSET was originally included in the settlement as undistributed specific grant of £1.4 million. Provision for INSET is now contained in the National Priorities Action Fund (NPAF) Specific Grant with no undistributed amount and has subsequently been removed from Total AEF.

However, in previously removing INSET from Total AEF, a further £1.4 million was added in error to Total AEF resulting in what is now a £2.8 million reduction in Total AEF to correct the position.

# 7. Specialist Provision Programme

The £5 million originally undistributed within Total AEF has been removed as this is now a grant outwith AEF (see **Annex I**).

# Reallocation within AEF

### 8. Transfer of RSG to Police Specific Grant

50% of the Scottish Crime and Drug Enforcement Agency's non-staff costs for the Operations and Intelligence Group is being returned to Police Central Government to ensure that Common Police Services falls wholly on it. Therefore, £3.528 million will be transferred back from RSG as a result of authorities no longer being requested to meet these costs.

### **Distributional changes**

# 9. Redistribution of Fire GAE in the Highlands and Islands

Following a request from the Highlands and Islands Fire Board, the Fire GAE allocations for each of the constituent local authorities have been re-allocated to more accurately reflect each authority's Fire requisition.

### Changes Still to Come

## 10. Forensic Science funding included in Police GAE and Specific Grant

Following the Police Public Sector and Criminal Justice (Scotland) Act 2006, which established the Scottish Police Service Authority from 1 April 2007, it has been agreed to provide funding direct from the Justice Department for the Forensic Science Services in Scotland.

The Forensic Science Service will soon be transferred to the central agency which will be funded directly by the Executive. The provision is currently made within the Police GAE line and will be removed and transferred back to Justice Department. It is expected that around £20 million in total will be removed from GAE and the Police Specific Grant. Further clarification will be provided in due course and is expected to be provided in time to be included in the Local Government Finance (Scotland) Order 2007.

### 11. Additional funding for the Electoral Administration Bill

The Electoral Administration Bill provisions extend to Scotland specifically on matters relating to the franchise (electoral registration, etc) and the conduct of parliamentary elections. The main provisions in the Bill, which came into force in 2006-07, relate to new duties which Electoral Registration Officers will be required to undertake. Additional funding of £2.301 million will be provided through the core settlement and the change included in the Local Government Finance (Scotland) Order 2007.

is the assessment of the floor adjustment for each local authority. The figures were Column 5 calculated as shown in Annex D.

Column 6 is the total of columns 1 to 5 and is the Total Estimated Expenditure (TEE).

#### **FUNDING**

is the forecasted number of Band D equivalent properties as at September 2004 on Column 7 which council tax will be levied.

Column 8 represents the proportion of deducted TEE which is not supported through AEF. This amount is distributed amongst councils in proportion to their share of the national council tax base for 2007-08 and achieved by using the following formula

> (Total adjusted TEE less total AEF) X Band D equivalent properties in each local authority total Band D equivalent properties

is the total amount of AEF which is calculated by subtracting column 8 from Column 9 column 6. See Annex A for further information on AEF totals.

Column 10 shows the amount of specific grants (including Police Specific Grant Loan Charges) for 2007-08. A number of specific grants (e.g. Police) are paid directly to joints boards and in these cases, for AEF distribution purposes only, the estimated amount for each force or brigade has been broken down on the same basis as is used for the relevant GAEs. Distribution to constituent local authority level of Police Specific Grant Loan Charges as used in the calculation of Police Specific Grant for 2007-08, has been based on advice from treasurers of the Police Boards.

shows the amount of Distributable NDRI. This is distributed amongst councils in Column 11 proportion to 2005 mid-year population estimates.

Column 12 distributes RSG and is the remainder of AEF after deducting Specific Grants and Distributable NDRI.
