Glasgow City Council (GCC) would agree that support provided directly to carers, in their own right, should not be subject to charge. (Lines 1 and 2)

Clear guidance is required around these draft regulations.

Individual budgets will have a financial limit and this will be based on eligible need and carers and the cared for will be able to exercise choice and control as to how these budgets are spent.

The level of funding for short breaks/ respite will be set by the local authority. If carers decide on a more expensive break then they should be required to meet the additional costs.

Any guidance needs to give clarity about what is meant by "whole cost".

In exercising choice and control there will be an element of flexibility around what is purchased to meet the assessed need but local authorities cannot be expected to meet additional costs if the carer chooses to take a holiday abroad.

Where the local authority assesses the need for a break for the carer any additional expenditure associated with the needs of the cared for person should include the use of welfare benefits (for example, DLA)

The significant challenge around these proposals is "how will these be funded".

A duty to deliver on these proposals will reduce the finances available to Local Authorities (LA) for carer supports and may result in greater prioritisation of those carers eligible for support leading to a reduction in resources available for a more preventative and anticipatory approach to supporting carers

Our view is that mobility benefits from the Department of Work and Pensions (DWP) should be used to fund transport costs with NHS being responsible for providing transport to NHS appointments.

Question 2(d): If there are further examples that you would like to include in the list, please state these below and also set out your reasons for suggesting their inclusion.

There are significant challenges in managing budgets and getting support to those in greatest need. Glasgow's carer assessments process has also contributed to budget allocation in the Self Directed Support (SDS) process to ensure those at greatest risk access appropriate care budgets.

There are also significant issues around the blurring of who the short break is delivering better outcomes for – Service user or carer – i.e. A day care placement could provide respite for a carer, but would also provided social stimulation and safety for the service user, so how do you decide who should pay for the service?

A move towards a model where the state funds holidays or respite could be a regressive step. This could create dependency for people with caring responsibilities. An ageing population will place significant demands on services and could easily create carer expectations which are financially unsustainable and contradicts the ethos of social work and shifting the balance of care.

There has been a significant shift in supporting carers from resource driven to outcomes focussed. A focus on the right to respite as a key resource as opposed to what outcomes are important to the carer and patient could also be a regressive step.
