- 1. We welcome the flexibility that would allow but does not require children's services to be included.
- 2. We welcome the flexibility that would allow the hospital and acute services to continue to be managed through day-to-day operational management arrangements for local hospital services. We do not think the terms used to describe some hospital services are helpful because they are unclear and poorly defined, e.g. unplanned inpatients, outpatient Accident & Emergency services.
- 3. We believe this flexibility is essential for small hospitals because of the challenges with disaggregating services where the staffing and activity are shared across a number of services e.g. staff providing input to both planned and A&E services.
- 4. While we agree with the importance of ensuring that strategic planning for services such as unscheduled care are the responsibility of the Integration body (and included within their Strategic Plan) we do not agree with the premise that this requires the inclusion of all funding associated with these services within the Integration Body. We believe this will lead to an unnecessary level of bureaucracy, particularly in small health systems. We would welcome guidance that sets out the principle of joint strategic commissioning with visibility of budgets for planning purposes, and joint budget setting to support jointly commissioned services.
