

CONSULTATION QUESTIONS

1. Do you agree with the list of Local Authority functions included here which must be delegated?



2. If no, please explain why:

The Regulations, as drafted, are too broad and include a number of housing related functions that may not be appropriate. Grampian Housing Association feel that these should be further defined to cover specific tasks/services that relate directly to Health & Care outcomes rather than whole sections of legislation.

We consider it essential that the homelessness function and responsibility should remain within Local Authorities and also those services delegated to registered social housing providers.

Housing Support services needs to be defined clearly to ensure that services relating to tenancy sustainment are excluded from the scope of the regulations.

We recognise and fully support collaboration and close co-operative working between social housing providers and health and social care partnerships across the Grampian Health Board Area.

The development of robust strategic frameworks between all equal partners, including housing providers, will help to achieve the nine outcomes effectively and efficiently.

3. Are there any further comments you would like to offer on these draft regulations?

Grampian Housing Association would highlight the significant role that Housing has to play in achieving the majority of outcomes. Although the Cabinet Secretary for Health has acknowledged the importance of Housing in the context of Health and Social Care integration, this appears to have been seriously underestimated in both the drafting of the regulations and in terms of the future role of Housing. It is the view of social housing providers operating in the Grampian Health Board area that there are good working practices in the North East at both a strategic and operational level which will provide a platform for the new partnerships and in the achievement of improved outcomes.

We are in agreement that funding for Aids and Adaptations should be part of the delegated functions but would recommend a tenure neutral approach is considered.

Before guidance is issues, further detailed discussions are required regarding which housing support functions are suitable to be included within the scope of the regulations.


