The inclusion of Adult Protection and Domestic Abuse, while very appropriate in principle, causes some complexity in relation to interagency governance of Community Safety.

It is vital that, with the move to integration, there is full recognition of the importance of maintaining/strengthening links with other Council services such as housing, employability and welfare rights even though it would not be appropriate for them to be in scope.



Outcome 8 (Staff) and Outcome 9 (Resources), while supported, are in essence inputs rather than outcomes so their inclusion risks some confusion about terminology
