- 5. Are there any further comments you would like to offer on these draft Regulations?
 - It is welcomed that there is a strong emphasis on effective performance management which will enable measurement of the progress that H&SCP's are making against the National Outcomes Framework. It would however be helpful to ensure that those key measures linked to national policies, such as on alcohol and drugs, are included in the performance frameworks for H&SCP's and the Community Planning Partnerships. This will provide for regular and more detailed progress reports through Alcohol and Drug Partnerships operating within the H&SCP areas.
 - The schedule identifies the requirement for clinical and care governance to ensure that services are safe, effective and person centred and that staff involved in delivering treatment and care are appropriately regulated. The focus is however on statutory agencies. Given that the new Integration Authorities will be required to undertake Joint Strategic Commissioning for services for all community care groups, including those for alcohol and drug services, it would be helpful if the guidance emphasised the importance of

- similar care governance and staff regulations within Independent and Third Sector Organisations who are very likely to be commissioned to provide a proportion of the services to people in need.
- In the section on structural arrangements within the new Integration Authorities it would be helpful to see how they are expected to link with ADP's to ensure effective needs assessment, strategic planning and delivery of these specialist services.
- There is a number of Alcohol and Drug Partnerships operating within Community Planning Partnerships which in many ways are a blueprint for the roles that the Integration Authorities are being asked to fulfil. These ADP's have undertaken needs assessments of their communities which have been used to inform their strategic plans. The strategic plans have then been used as the foundation to both the commissioning of services and their delivery. These services are then subject to robust performance management arrangements to ensure that providers are meeting expected outcomes.
