There remains lack of clarity on lines of governance, highlighted in the session with Board and Local Authority Chief Executives and output of the work which was agreed to be taken forward from that event.							
The regulations should more clearly state that the IJB will have planning and service delivery responsibilities. With the strategic plan setting out the intentions of the Partnership for the full range of adult health and social care services which it manages on behalf of the parent bodies and those services for which it has a planning responsibility, including acute care, with the Health Board. There are a number of Local Authorities still of the view that the Partnerships will be strategic planning not integrated delivery organisations.							
Further work is required to ensure there is clarity on the relationship between the CO, the CSWO and other professional advisers. The IJB should include professional advisers for at least nursing, medical AHP and social work. There needs to be a clear process for this work.							
In board areas with more than one Integration Authority, Regulations should make explicit the requirement for partnerships to consider the aggregated impact of their plans on the acute system. It has been suggested that the health board develops and owns a Hospital Plan through consultation with the partnerships.
