- In the table: Under AHPs - there is insufficient definition of the work that we do - the table states: 'To provide assessment, investigation, diagnosis, care planning and treatment of patients'.

The AHPFS would advocate the extension of the definition 'What does the service involve' to include 'across a full range of physiological and psychological services'.

In the table: Under Health Promotion 'Where is the service delivered?' the AHPFS would suggest that 'hospitals' should be included as hospital based AHPs may discuss aspects of health promotion with patients as this sits within the potential developments under the AHP National Delivery Plan.

- In the table (and in the regulations themselves): Under 'Pharmaceutical services - GP prescribing' - the professions listed are 'GPs, nurse prescribers, prescribing pharmacists working in GP practices' and that they 'provide the full range of prescribing services set out in legislation and guidance'.

Whilst it is recognised that under the regulations that 'integration must include all adult provision; inclusion of children's services in integrated arrangements is left to the discretion of local partners', the AHPFS believes that there should be clear guidance on transitional arrangements between adult and child services where those services are not jointly included in local integration agendas.
