The commitment to work closely with unions is welcomed. However the proposal to include a staff side representative could cause difficulties. The different ways of working with unions between Councils and the NHS will mean that it is difficult to agree which sector's union holds the non-voting seat. It may be better, in order to resolve this, that partnerships are required to demonstrate how they will maintain engagement with unions through existing mechanisms such as Joint Consultative Groups.

Section 95 Officer role will require to provide advice to the IJB and it is recommended that the role should be added to the minimum list of non-voting members.

There should be some consideration that the strategic housing authority should also be a non-voting member of the IHB.

3. Are there any other areas related to the operation of the Integration Joint Board that should also covered by this draft Order?

No comment to make on this.

4. Are there any further comments you would like to offer on this draft Order?

It is the understanding of East Lothian Council and NHS Lothian that the section on voting membership allows 4 voting members from each. This is the current configuration of the Shadow Joint Board in East Lothian and both wish to retain this.

It is assumed that the definition of a quorum (at least 2/3 of the voting membership from each of the Council and NHS) in the draft schedule of matters to be included in standing orders can also apply to a membership that is not divisible by 3 e.g. where each body has 4 voting members. Also, consideration should be given to whether 2/3 quorum will work in practical terms especially in areas where a health board has a number of IJBs.

It is assumed that details in areas on which the regulations are silent (such as the process for selecting the chair and vice chair, process for agreeing terms of office, process for agreeing the full non voting membership etc.) will be developed and agreed locally.

It would be helpful if there is clarity on the role of non-voting members such as the role of advisor and whether or this raises any conflict issues.


