The consultees in relation to housing are insufficient. It is noted that both commercial and non-commercial providers in relation to health as well as social care are included, yet it is only non-commercial housing interests, which are to be consulted. In our view this should in particular make reference to those with strategic responsibility for housing e.g. the Local housing Strategy Manager. This is especially important in areas where the local authority does not own any housing stock. Service users of supported housing would also have a valuable role in helping to set the agenda.


3. Are there any further comments you would like to offer on these draft Regulations?

We trust that guidance will clarify that the third sector bodies to be consulted should normally be representative bodies rather than individual providers who may have vested interests.

It is extremely important that a senior housing professional with strategic responsibility for housing is represented. One of the main trends is towards care at home. It is an astounding omission that housing is not mentioned.

There should be clarity about what type of third sector representative is envisaged. It should normally be from a representative body rather than a provider potentially with vested interests.

3. Are there any other areas related to the operation of the Integration Joint Board that should also covered by this draft Order?

4. Are there any further comments you would like to offer on this draft Order?

The use of the term third sector bodies carrying out activities related to health and social care seems to imply a direct service provider (which is likely to be in commercial competition with other 3<sup>rd</sup> sector providers in the area). Far better would be to ensure that where possible representation is through a representative body.
