- 2. To invite members of the RDOC to provide comments/feedback on the draft work programme.


Background

The Scottish Rural Network (SRN) is funded under the SRDP Technical Assistance budget and has the following aims, as required by EU Regulations:

- Increase the involvement of stakeholders in the implementation of rural development;
- Improve the quality of implementation of the rural development programme;
- Inform the broader public and potential beneficiaries on rural development policy and funding opportunities;
- Foster innovation in agriculture, food production, forestry and rural areas.

The SRN has an Action Plan for 2014-20, which the RDOC has seen. The Action Plan sets out the purpose, governance, planning and delivery arrangements for the SRN. The 2019/20 Work Programme sits underneath the Action Plan and sets out the activities the SRN will deliver from 1st April 2019 to 31st March 2020.

The work programme is supported by a communication plan and a monitoring and evaluation plan. It also forms a vital part of the SRDP Annual Communication Strategy, with a single activity planner that sits across the SRN and all the SRDP schemes.



Development of work programme

SRN activities are driven by both the legal requirements and by stakeholder needs. It is informed by a wide range of events, workshops and meetings the SRN has delivered over the last two years, as well as an annual online stakeholder survey. A more comprehensive operational plan has been developed by the SRN for period 2019-20 which has inform this document and gives a greater level of detail around individual tasks and purpose.





Priorities for 2019/20 Work Programme

Key priorities for the SRN this year include:

The SRN will deliver specific activities to support SRDP objectives including:

- Support the 'Innovation Support Service', aimed at increasing collaborative innovation in the agricultural, food and drink, and forestry sectors and promoting RISS outputs to appropriate audiences
- Increase the number of project case studies available on the SRN website and other channels to include examples from the majority of the SRDP schemes.
- Deliver a SRDP legacy document with a comprehensive set of examples and lived experiences, and positive stats/infographics to illustrate economic and social impact.
- Implement the recommendations from the website user testing with a view to improving navigation and increasing traffic, dependent on budget availability
- Improve coordination of communications across the SRDP including audit of all existing case studies across schemes in order to conduct gap analysis
- Support LEADER working groups including facilitation, communication of outputs, etc.
- Produce a series of short videos (one per month) to demonstrate the impact of SRDP funding and to promote and encourage rural development.
- In line with the Aims and Objectives of the 2020 Year of Coasts and Water, the Scottish Rural Network and the Network Support Unit will also actively seek to work in partnership with other partners, including (but not limited to) Visit Scotland, SRDP leads, Marine Scotland, local authorities and Local Action Groups in the development and delivery of activities ensuring an inclusive approach is taken throughout the Year and beyond, creating a lasting legacy
- Support other teams within Rural Economy and Communities to deliver work stream priorities e.g. Islands team (social channels set up, comms plan initiated, promotion of launch of engagement exercise, etc), National Council for Rural Advisors policy team, etc.
- Support SG policy areas to deliver objectives which require rural perspective e.g. rural housing policy, Exchequer colleagues, etc.

The SRN will also maintain a number of regular, on-going activities including:

- Producing a weekly e-newsletter to more than 1,457 subscribers.
- Maintenance of SRN website and social media feeds.
- Building relationships with and between key stakeholders.
- Collating and issuing a monthly LEADER newsletter to more than 264 subscribers

Annex A: Activities in 2019/20 SRN Work Programme

Listed below are all the activities the SRN aims to deliver in 2019/20. Many of the activities are already well defined, but some need further work to develop exactly what needs to be delivered. The costs and resources required to deliver each activity vary considerably. The activities are grouped under logical headings, but are not presented in any particular order.

- Produce a range of case studies to support SRDP legacy and learning and CLLD (12 films: 1 x per month and 120 written: 10 per month) featuring rural development projects/initiatives (including LEADER, RISS, etc.)

- Support relevant celebration/awareness days/weeks e.g. Mental Health Awareness
 Week (13-19 May) through social media and newsletter activity
- Support coming Year of Coast and Waters activity through social media, website/newsletter channels, possible event hosting, etc.
- Support Woman in Agri including networking/bench marking events and messaging via social media channels and newsletter content
- Communicate information on relevant Brexit developments and impacts to rural stakeholders
- Hosting of LAG-only area of SRN website
- Publication: weekly SRN newsletter
- Publication: monthly LEADER newsletter
- Publication: SRN funding newsletter
- Publication: Updated SRN flyer
- Publication: SRN Highlights for financial year 2018-19
- Publication: SRDP promo flyer/material as required
- Publication: Summary of 2019 SRDP Annual Implementation Report
- Publication: SRDP legacy document with short supporting video
