ESF/ERDF - OPERATIONAL PROGRAMMES

Purpose

1. To provide members with details of the proposed changes to the ESF and ERDF operational programmes. The summary also details the rational and methodology applied by the Managing Authority (MA) in developing the revised programme.

Recommendation

2. That members endorse the changes to the operation programmes and are content for the MA to submit the revised programmes to the EC for final approval.

Performance Reserve

3. The performance reserve for ERDF has all been reallocated to Priority 5 (Transition and More Developed) and removed from all priorities that did not achieve their milestones, with the exception of those priorities who achieved their milestone i.e. Priority 3, Transition and Priority 5, Transition and More Developed. This is reflected within the ERDF table in ANNEX A.

De-commitment

4. The total de-commitment figure for 2019 is €19,682,525 which is comprised of €3,485,657 within Transition and €16,196,868 in More Developed.

Transition:

5. The MA has removed a consistent percentage (approximately 3%) from each priority. Applying this percentage allows sufficient funding to support all project and programme activity supported through the approved SI's within each priority.

More Developed:

6. Applying the same process, the MA has removed a consistent percentage from each priority (approximately 5%). Applying this percentage consistently allows for sufficient funding to support all project and programme activity through the approved SI's within each priority.

ESF

Performance Reserve

7. The performance reserve has been allocated to the one priority that achieved its milestones, Priority 1 More Developed, and removed from all other priorities. This is reflected within the ESF table in ANNEX A.

De-commitment

8. The total de-commitment figure for 2019 is €32,539,404 which is comprised of €6,876,386 within Transition and €25,663,018 in More Developed.

Transition:

9. The MA has removed a consistent percentage from each priority within transition (approximately 10%), with the exception of Priority 5 which was nearing full commitment. Applying this percentage consistently allows for sufficient funding to support all project and programme activity through the approved SI's within each priority.

More Developed:

10. Applying the same process, the MA has removed a consistent percentage, (approximately 13%) from Priorities 1 and 2 only - Priorities 3 and 5 are close to full committed. Applying this percentage consistently allows for sufficient funding to support all project and programme activity through the approved SI's within each priority.
