2. Programme update

Partnership Agreement

- All funding programmes continue to make commitments across Scotland.
- Delivery of the European Social Fund (ESF) and European Regional Development Fund (ERDF) programmes have continued against the respective Operational Programmes. Extensions and new operations have continued to be considered and approved. To date £572m committed out of a total value of €872m (£745mbased on £1: €1.17).
- Programmes are currently in suspension, we are working closely with the EC and lead partners to resolve the issues raised.
- Annual Implementation Reports have been submitted.
- The recent consultation to consider the replacement of the ESF and ERDF programmes closed on 12 February, and a report, led by Professor David Bell, was published on 12 June 2020

EU exit/future issues

- Funding guarantees SRDP projects are guaranteed, for the lifetime of the project, and all contracts are planned to be entered into before 31 December 2020.
- Officials have received a paper from HMT on farm funding, it confirms the quantum of funding that HMT propose meets the 2019 Conservative Party manifesto commitment but this does not meet Scottish Government expectations.
- Along with the other Devolved Adimistarion's a number of key concerns have been raised which need to be resolved in advance of the Comprehensive Sending Review.
- 2021 24: Proposals focus on retaining existing CAP schemes, in broad terms, to provide certainty for farmers and land managers, while simplifying the administration of those schemes. The Agriculture (Retained EU Law and Data) (Scotland) Bill passed Stage 3 on 26 August and enables us to deliver the proposals set out in Stability and Simplicty consultation. With the Bill passed work is underway to ensure the necessary secondary legislation is in place for those schemes to be available in 2021.
- An Agricultural Transformation Programme has been announced to focus on climate change, sustainability, simplicity, profitability, innovation and productivity.
- 2024: The Farming and Food Production Future Policy Group (FFP-FPG) last met on 23 September and agreed that they need to meet further in order to finalise their Report. As an independent Group, it will be for the Group to determine when it is ready to publish its Report, however we do expect that the Report will be published this year. Updates are available at

• The Commission have introduced legislation to extend the current CAP for a year in recognition that there will be a delay in the implementation of the new CAP.

3. Programme monitoring

Modification

Update

- It is expected there will be a seventh modification before the end of this year, to align measure budgets to final spend to allow for a smooth closure process.
- Work is currently underway to prepare for submitting this modification to the Comissions. The RDOC will be consulted and provided with the opportunity to provide an opinion on the proprosed modification in due course.

Monitoring & Evaluation

•A process evaluation of LEADER and a more detailed evaluation by SRUC have been published. The evaluations raise interesting questions for the development of similar policy in the future. The evaluations can be found here:

- •The evaluation of AECS by NatureScot will take the form of two papers, both of which are now complete and awaiting publication. The first paper is a commissioned piece provided by the James Hutton Institute, and provides field studies and interviews within the context of three case studies. NatureScot report that the overall results of the project indicate that the scheme is benefitting biodiversity. This report will be published soon. The second report provides heat maps looking at uptake, number of hectares and funding spend on key options. The update provided highlights some key benefits that have resulted from the scheme.
- •The SRN evaluation has been completed and will be published on 6 November.
- •Assuming that there are no further delays, New Entrants/Young Farmers survey will have been launched by the RDOC meeting. If not, we will update on this verbally.
- •The FAS one to many evaluation has been completed, and will be published following review. This is expected by the end of November.
- •The KTIF evaluation is currently in development. Key research questions have been identified but further discussion of the available data and key policy concerns are ongoing. The evaluation is expected to commence in January.
- Conversations between RESAS and FGS are ongoing regarding the planning of a series of commissioned evaluations on specific FGS schemes.

AIR - Annual Implementation Report

- Due to the COVID-19 pandemic, the deadline for submitting the AIR 2019 to the European Commission (EC) was extended to the 30 September.
- The AIR 2019, covering the calendar year 2019 and the period from 2014 to 2019, and the Summary for Citizens were submitted to the EC at the end of July.
- The EC accepted the AIR 2019 at the start of August.

4. Communications

SRDP Communications

- Since the Annual Strategic Communications Plan for 2020-21 was published the impacts of Covid-19 have required a refocus of activity and related communication and support. This included:
 - As part of the response phase SRN and ARE Comms have communicated support to rural stakeholders including business grants, mental health support, location of mobile testing units, sector specific guidance to the agri and hospitability sectors, promotion of consultations and surveys by SG policy areas and other stakeholders regarding Covid-19 to rural and island audiences, etc.
 - Recovery phase has focused on raising awareness of ongoing developing guidance and advice, sharing examples of good practice to support rural stakeholders, promotion of webinars and virtual events to support good practice, etc.
- Activities for remainder of 2020-2021:
- Promotion of key SRDP dates/milestones in run up to programme end
- Communicate details of future programme schemes as information is made available
- Continue to inform stakeholders re announcements about Covid-19 support and guidance
- Continue to inform stakeholders re announcements about Brexit and guidance
- Promote legacy of current SRDP scheme.

Scottish Rural Network

- The SRN Team have been working at reduced capacity since February 2020, with a headcount of only three. This has resulted in cut back of planned and proactive activity to focus on COVID-19 messaging and response.
- Despite this the team have maintained daily social media content posted across a range of platforms, publication of the weekly newsletter, updating of website content (including COVID-19 hub) and promoted various SG and stakeholder consultations regarding COVID-19 to rural and island communities
- Continued to work closely with Rural Youth Programme (RYP) to support engagement with young people in rural and island communities including support to the Minister for Rural Affairs & Natural Environment at various meetings with follow up actions with a with a range of youth related groups. Currently developing work on a roundtable discussion of key youth organisations with a rural and island remit.
- Working with National Rural Mental Health Forum to scope out commissioning research into the mental health impacts of COVID-19 on lesser heard voices with rural and island communities
- Promoted Scottish interests and innovation from a rural perspective by utilising various theme days/weeks e.g. Mental Health Week, World Forestry Day, etc.
- Worked with Scottish Rural Action (SRA) to scope a virtual large scale online event. Procurement exercise completed for online events company. Discussions on going as whether event will be a full Scottish Rural Parliament or a lead up event.
- Scoping commissioning of research and learning into the opportunities to rural and island communities of the motorhome and campervan tourism sector. Meetings with enterprise agencies, RESAS, Visit Scotland and SG Tourism policy undertaken and draft research questions identified for review by working group.
- COVID-19 hub maintained on SRN website targeted at rural audience and stakeholders. Information on locations of mobile testing units added as seperate page with weekly social media messaging to support
- Worked with Local LEADER teams to develop a social media campaign promoting LEADER response to COVID-19 (#ResilientRural)
- Development of projects to utilise TA allocation within remaining programme period.

5. Finance

Budget

- Total budget remains €1.5bn (or 1.22bn sterling assumed exchange rate of €1.20 = £1).
- The co-financing rate is 52% EU funds: 48% SG funds from 01 Jan 2020.
- Pillar 1 to Pillar 2 transfer remains at 9.5%.
- The vast majority of budget committed and with on-going pressures on SG budgets there is very limited flexibility for remainder of programme.
- Modification 7 will focus on minor changes, aligning budgets from those where they
 have already delivered against the objectives set to those were we wish to continue to
 delivery the benefits of the scheme.
- SG 2020/21 budget was annouced on 6 Feb 2020 before the UK March Budget and is in line with the latest modification.
- The UK Government has agreed to repay £160 million CAP convergence funds owed to Scotland's farmers and crofters.
- In March Convergence payments were made to 17,900 farmers and crofters with the total value of payments processed over £88 million.
- For Convergence 2020 we intend to commence payments in January 2021 (complete by 31 March 2021) paying the remaining £71.80 million of the £160m pledge from UKG.
- The intra-UK funding allocations review under Lord Bew has concluded, with the UK Government accepting the recommendations. Scotland expects to receive £25.7m in 2020/21 and £25.7m in 2021/22.
- Careful monitoring of the budget will continue this year especially in light of the concerns already raised in relation to meeting contract requirements. Businesses have been impacted by COVID-19 and we will continue to monitor progress against commitments as we move from a period of response to recovery.

6. Error Rate Action Plan

Error Rate Action Plan

- The Error Rate Action Plan is in place to identify remedial action for deficiencies found in the management and control system. Those action plans are then assessed by the Commission to check whether they would, if properly implemented, actually remedy the identified deficiencies in due time.
- At the current time there is no Error Rate Action Plan.
- There are currently no reservations relating to other EC related audits or the DG Agri Annual Report. We have just completed an audit of Capital Investment Measures and await the Letter of Observation from the Commission.
