PRE-SCHOOL AND CHILDCARE STATISTICS 2010

29 September 2010



Scotland's Chief Statistician today published <u>Pre-school and Childcare Statistics</u> <u>2010</u>, which presents new statistics on childcare centres and childminders registered with the Care Commission, and childcare centre staff.

The main findings are:

- As at January 2010, there were 4,125 registered childcare centres, a decrease on the 4,274 of January 2009. Of these centres, 4,056 were operating, 63 fewer than in 2009. (Table 1)
- At January 2010, there were 2,615 centres that provided local authority funded pre-school education, 30 fewer than in 2009. (Table 1)
- At January 2010, there were 1,613 whole time equivalent (WTE) GTCS registered teachers providing pre-school education under a regular arrangement, 25 WTE fewer than in 2009. (Table 28)
- At January 2010, 74% of pre-school children had access to a GTCS registered teacher during census week, a 4 percentage points increase compared with 2009. (Table 24)
- At January 2010, 94% of local authority pre-school centres had GTCS registered teachers who provided pre-school education under a regular arrangement, compared with only 36% of partnership centres. (Table 30)
- At January 2010, 74% of the childcare workforce had a childcare qualification at SVQ level 3 or above, an increase of 1 percentage point compared with 2009. (Table 15)
- At January 2010, 27% of childminders had a childcare qualification at SVQ level 3 or above, an increase of 2 percentage points compared with 2009. (Table 21)

Childcare Centres and Services (Tables 1-10)

- As at January 2010 there were 4,125 registered childcare centres, a decrease on the 4,274 of January 2009. Of these centres, 4,056 were operating, 63 fewer than in 2009 (Table 1, Table 2).
- There were 2,615 centres that provided local authority funded pre-school education at January 2010, 30 fewer than at January 2009 (Table 1).
- The number of registered childminders increased from 6,039 in January 2009 to 6,066 in January 2010. If inactive childminders are excluded, this figure is 5,559. (Table 1, Table 19).
- The main service for 60% of operating childcare centres was a nursery. Eighty per cent of all operating centres provided an outdoor play area (Table 2, Table 5).
- A total of 201,180 children attended childcare centres during census week, and 28,640 attended childminders. These figures may include some multiple counting as children are counted once for each centre and/or childminder they attend (Table 9).
- The percentage of centres that had a plan or strategy detailing how they will meet the requirements for registration with the SSSC rose from 76% in January 2009 to 81% in January 2010. These figures are based on the centres that returned full census forms (Table 10).

The Childcare Workforce (Tables 11-18)

- There were 26,010 paid staff working directly with children in childcare centres in January 2010, of which 85% were permanent and 50% were part time (Table 12).
- Just under a third of centres used unpaid volunteers working directly with children at January 2010 (Table 18).
- At January 2010, 99% of active childminders were female (Table 19).
- At January 2010, over three quarters of currently active childminders worked 30 or more hours per week and 15 per cent worked more than 50 hours. Most childminders (77 per cent) worked more than 40 weeks per year. These figures are derived from the Care Commission's December 2009 Annual Returns and are outwith the scope of National Statistics (Table 19).
- At January 2010, the percentage of childminders with a childcare qualification at SVQ level 2 or above increased by three percentage points to 32 per cent and the percentage with SVQ level 3 or above increased by two percentage points to 27 per cent compared with 2009 (Table 21).

- The number of managers of Day-care and Pre-school Education centres, together with the number of paid staff working directly with children in 2010 was 30,480 (Table 13).
- At January 2010, 15% of the childcare workforce were managers (Table 13).
- At January 2010, 95% of the childcare workforce in 2010 were female (Table 13).
- At January 2010, 84% of the childcare workforce had a childcare qualification, the same as in the previous year. Eight two percentage of childcare workforce had a childcare qualification at SVQ level 2 or above, the same as in the previous year. The percentage with a childcare qualification at SVQ level 3 or above increased by 1 percentage point to 74% (Table 15).
- Childcare staff working in public sector childcare centres were more qualified than those in the private or voluntary sectors. At January 2010, 87% of staff in public sector centres had childcare qualifications at SVQ level 3 or above, compared to 69% in private and 59% in voluntary centres (Table 16).
- At January 2010, nearly two thirds of childcare staff who were managers had childcare qualifications at SVQ level 4 or above (Table 16).
- At January 2010, there were 1,250 staff of all levels working towards a childcare qualification at SVQ level 4 or equivalent, and a further 1,310 staff of all levels were working towards a degree level childcare qualification (or equivalent). This compares to 1,190 staff of all levels working towards a SVQ level 4 or equivalent childcare qualification, and 940 staff working towards a degree or equivalent level childcare qualification in 2009 (Table 17).

Pre-school education (Tables 22-31)

- At January 2010 there were 2,762 centres that provided pre-school education following the Scottish 3-18 Curriculum for Excellence. Of these, 2,615 centres were local authority or partnership pre-school providers, a fall of 1 per cent compared with January 2009 (Table 22).
- At January 2010, there were 107,420 children registered for pre-school places funded by the local authority (Table 23).
- At January 2010, 96% of children eligible, or 99,690 in total, were registered for the ante-pre-school or pre-school year of pre-school education, similar to the previous year. This figure is based on a series of estimations and some children may be counted more than once if they are registered to receive local authority funded pre-school education at more than one centre (Table 23).
- At January 2010, 74% of pre-school children had access to a GTCS registered teacher during census week, a 4 percentage point increase compared with the previous year. This includes children whose access was to a teacher providing only ad hoc or occasional support to the centre during census week (Table 24).

- At January 2010, there were 9,230 whole time equivalent (WTE) staff providing pre-school education in local authority and partnership centres (Table 26).
- The January 2010 Census enables us to estimate the actual physical number of GTCS registered teachers who provide pre-school education under a regular arrangement, whether employed by the centre or shared with other centres. This has resulted in the following:
 - There were 2,970 GTCS registered teachers in posts providing pre-school education under a regular arrangement in January 2010. This compares with 2,880 in 2009. Please note that this includes multiple counting if a teacher works in more than one centre and this comparison is affected if there is a change in the level of multiple counting.
 - These 2,970 posts were filled by an estimated 2,610 GTCS registered teachers. This compares with 2,590 in 2009 and is the second time the actual number of GTCS registered teachers providing pre-school education under a regular arrangement has been able to be calculated.
 - The Whole Time Equivalent (WTE) of all GTCS registered teachers providing pre-school education under a regular arrangement in January 2010 was 1,613 WTE, which is 25 WTE fewer than in 2009.
 - See Table 28 for further details.
- At January 2010, information for 2,455 individual GTCS registered teachers was provided. This showed that 93% of them were female and 4% were male. The gender for the remaining GTCS registered teachers was not provided. (Table 29)
- In addition, the 2,455 individual GTCS registered teacher records showed that the average (median) age of GTCS registered teachers was 48 years old. However, the age for 10% of GTCS registered teachers was not provided (Table 29).
- At January 2010, 70% of pre-schools had GTCS registered teachers who provided pre-school education under a regular arrangement, whether employed by the centre or shared with other centres, an increase of 2 percentage points from 2009 (Table 30).
- However, by type of provider shows that 94 per cent of local authority centres compared with 36 per cent of partnership centres had GTCS registered teachers who provided pre-school education under a regular arrangement (Table 30).

BACKGROUND NOTES

- 1 This publication provides information about pre-school education centres, childcare centres and childminders registered with the Care Commission.
- 2 Historical statistics, notes on the background to the surveys, the questionnaires, guidance notes, and related publications can be found at <u>www.scotland.gov.uk/childrenstats</u>.
- 3 Census week was the week beginning 25 January 2010. Childminders also answered the survey for this week.
- 4 Of the 4,125 Care Commission registered services included in the January 2010 census, 3,633 (88%) completed the full census form; 149 (4%) completed a shortened pre-school education form, 69 (2%) responded saying that they had closed, were not currently operating, or the Census was not applicable to them. The remaining 274 (7%) centres did not respond to the survey at all.
- 5 When necessary, information used in January 2009 has been used to impute for those centres that did not return forms or did not complete specific questions.
- 6 For the third time, centres providing pre-school education were asked how many children had access to a General Teaching Council for Scotland (GTCS) registered teacher during census week. In the guidance notes "access to a teacher" was defined as "the teacher being present in a pre-school education setting when the child is in attendance", and it was acknowledged that systems for providing access to teachers vary.
- 7 Pre-school education centres were also asked for the third time whether they received occasional or ad hoc support from any external GTCS registered teachers. This could be instead of, or in addition to, any teacher(s) providing pre-school education under a regular arrangement.
- 8 For the Childminders Survey 1,191 registered childminders were sampled, of which 808 (68%) returned completed forms. The sample was stratified by urban-rural classification and area deprivation. Responses on the qualifications of childminders were grossed up to 5,559, the total number of registered childminders in Scotland in January 2010 excluding those listed as "inactive" by the Care Commission.
- 9 As in January 2009, to reduce the burden on childminders of completing the form, this year some information on their characteristics was taken from the Care Commission's December 2009 Annual Returns. As there was a level of non response to this return the numbers have been weighted up to the total number of registered active (5,559) and inactive (507) childminders as at 1 January 2010. These figures are presented in Table 19 and are classed as outwith the scope of National Statistics. The number of responses, the number of childminders, and the weights used are shown in Appendix 2.

10 The figures in Tables 14-17 and 20-21 show the numbers of childcare staff and childminders with qualifications at the level equivalent to the SVQs shown below.

11 Definitions of the services provided:

<u>Nursery:</u> This category includes daycare and pre-school centres for children aged 5 or under including local authority pre-school classes and nurseries; private and voluntary daycare nurseries including centres providing pre-school education in partnership with the local authority; and community and workplace nurseries. The services will normally be used by parents on a regular rather than a drop-in basis and be provided for at least the school term.

<u>Playgroup</u>: These provide sessional or day care for children aged 5 or under. Most are run by groups of parents with parent-led committees, although some may be owned by individuals or organised by other voluntary bodies or by the local authority. They rely heavily on parents/carers who volunteer their services although they may employ paid staff, e.g. a play leader or assistant. Some playgroups will provide pre-school education in partnership with the local authority.

<u>Out of school club:</u> Out of school clubs offer care for school age children in the absence of parents or carers from the end of the school day until parents can collect their children, and also before school starts.

<u>Breakfast club:</u> This is a specifically designated breakfast club that is likely to provide a meal and will take place before school hours.

<u>Crèche:</u> A crèche provides 'drop in' care for children in order to enable adults to engage in activities such as further education, shopping or attending a meeting.

<u>Children/family centre:</u> Child and family centres provide services similar to those available in community nurseries and nursery centres. Day care/education is provided along with a range of support services for families which can be adapted to meet local needs. They are usually managed by voluntary organisations or by the local authority's social work or education department.

<u>Sitter service</u>: A sitter service provides childcare in the family's own home from early morning until late evening seven days a week.

<u>Holiday play scheme:</u> Holiday play schemes cater mainly for school age children and provide opportunities for children to participate in a broad range of supervised leisure and educational activities during school holidays.

Family support services working directly with parents: This should be taken to mean services which goes over and above the normal contact that a childcare or education service would have with parents. These services give parents opportunities to assist their child's development and achieve greater satisfaction in their role as parents, to support them in providing a healthy upbringing for their child, to promote self-esteem and personal confidence in both children and parents and to provide opportunities for parents to acquire skills which lay the basis for more extensive training or subsequent employment.

<u>Professional health care:</u> Services provided by professional health staff such as midwives, health visitors, speech therapists, psychologists, doctors and dental practitioners including antenatal care, postnatal care and support, child health clinics/screening and support groups where these are run by health professionals.

Gaelic provision: Services wholly or primarily in the Gaelic medium.

<u>Outdoor play area:</u> Any area out of doors available to the children attending the centre, which may also be shared with others or available to the wider community.

- 12 Whole time equivalent is the total number of hours worked by all staff members divided by the number of hours in a standard full-time working week, which was specified as 35 hours.
- 13 The categories of urban-rural were derived from the latest Scottish Executive classifications available at the time of the Census. This provides a mapping from individual postcodes to six categories of rurality. Individual pre-school and childcare service providers were assigned to one of these categories based upon the category of the area in which they are located. Urban areas are settlements over 10,000 population. Small towns are settlements of between 3,000 and 10,000 people. Rural areas are settlements of less than 3,000 people. There are 32 childcare centres that do not have an urban-rural classification because their exact location (i.e. postcode) was not known.
- 14 The categories of deprivation were derived from the latest Scottish Executive classification available at the time of the Census. This provides an indicator of deprivation for each of the 6,505 data zone areas of Scotland. The category "least deprived" denotes the 33.33 per cent least deprived data zones, "most deprived" is the 33.33 per cent most deprived data zones and "intermediate" makes up the remaining 33.33 per cent. Individual pre-school and childcare service providers were then assigned the category corresponding to the data zone in which they are located.

21. **Review of Statistics - Future Changes**

The Scottish Government's Education Directorate has been undertaking a review of its existing statistical collections. As a result, the Scottish Government has decided on the following changes:

- The Scottish Government will not continue to conduct an annual **Pre-School and Childcare** Census in its existing format.
- The Scottish Government will continue to conduct an annual Pre-School Education Census. However, this Census will now take place in September (starting September 2010) to coincide with the Primary, Secondary and Special School Pupil Census that are carried out at this time of year. Results for all sectors of Education provision will be published together in a compendia publication the following December.

The benefits of this change is that the availability of information on Pre-School Education will continue, will be more timely and will be available at the same time as for information in relation to Primary, Secondary and Special schools.

22. **Review of Statistics - Proposed Changes**

As part of the review of statistics, the Scottish Government's Education Directorate are currently consulting on the following proposals:

- The Scottish Government will no longer conduct its own Childcare Census and Childminders survey. The reason for this proposal is that information about these childcare providers are also collected by the Care Commission. Therefore, the Scottish Government will work closely with the Care Commission in order for similar information previously collected and published by the Scottish Government will become available from their own data sources, from 2011.
- The Scottish Government will no longer conduct its own Childcare Workforce survey. Again, the reason for this proposal is that information about the workforce for the childcare sector is also collected by the Care Commission, and will be analysed by the Scottish Social Services Council (SSSC). Therefore, the Scottish Government will work closely with the Care Commission and the SSSC in order for similar information previously collected and published by the Scottish Government will continues to be available from these organisations, from 2011.

The benefits of these proposals are:

- The availability of information on Childcare provision, childminders and the Childcare Workforce will continue, but from alternative sources.
- The timing of availability should not be significantly affected.
- Burdens on data providers will be minimised as the duplication of information provided by Childcare providers and Childminders to both the Care Commission and the Scottish Government will be eliminated.

The number of childminders is the number registered with the Care Commission as at January 2010, and includes inactive childminders (8 per cent of total in 2010).

The number of childminders in 2006 and 2007 has been rounded to the nearest 10, as presented in previous years.

Where childcare centres did not provide information, the previous year's information has been used, where available.

The number of centres is the number registered with Care Commission when the census form mailing was being prepared (usually around November of the previous year). Each year some centres reply to the mailing to say that they were closed or not currently operating.

The number of pre-school providers decreased in 2008 due to better identification of pre-school centres that were not in partnership with the local authority.

Information on sitter services was not collected prior to 2007.




Chart 1: Total number of childcare centres and childminders by main service type, January 2006 to January 2010




Chart 2: Main service type of active childcare centres by area deprivation, January 2010





Local authority percentage estimates are based on the local authority in which each centre is located, and estimates of the number of children in each local authority eligible for pre-school education. See Appendix 1 for population estimates.

As children may cross local authority boundaries to attend pre-school education or attend more than one centre, and as population figures are estimates the above percentages should be treated as estimates and interpreted with caution.




Chart 5: Age profile of GTCS registered pre-school teachers, January 2010

Where possible, information used in 2009 has been carried forward for those centres who did not complete a full census form in Figures are possibly a slight undercount as some centres may never have answered this question (in 2008, 2009 or 2010) so we do not know whether their teachers do any of the above.
