# OSR Compliance Check & Future Developments



### Compliance Checks - What are they?

- Carried out by the Office for Statistics Regulation (OSR), part of the UK Statistics Authority
- Compliance checks are short, focused reviews, typically providing a high-level investigation of the extent to which statistics meet the standards of the <u>Code of Practice for Statistics</u> – Trustworthiness, Quality and Value.
- Ensure that National Statistics publications are keeping up their high standard and compliance with the Code

Completed end 2018/start 2019

Letter to SG Chief Statistician outlining findings published in February 2019

Maintained National Statistics status



Highlighted some good points

• Stated a number of improvements that could be made

### Good points

- The Homelessness Statistics Users Group
- The statisticians' ongoing work with local authorities to quality assure the quarterly data submissions.
- Assessing the robustness of data received via the new 'HL3' case-level temporary accommodation returns
- Scottish Government's recent published research exploring the relationship between homelessness and health - we think this is a great example of innovation,
- Developing and publishing the PREVENT1 publication as Experimental Statistics since 2010/11 to reflect a new data collection on the operation of Housing Options services
- Planned collaboration with National Records of Scotland to develop and publish new statistics on deaths of homeless people in Scotland

- Review and update existing published information about data governance.
- Review and update published information about the methods used to produce the statistics, the quality and quality assurance of the statistics.
- Improve the accessibility between the main statistics publications, supporting guidance and data tables across Scottish Government's new website.
- Increase the insight presented through the presentation of Homelessness in Scotland, including:
  - Refining the commentary to focus on drawing out the key messages from the statistics
  - Review the suitability of the charts and diagrams
  - Seek opportunities to present more insight on the topic of homelessness and to explain trends over time,
  - Strengthening guidance about the comparability of the statistics with related statistics across the UK.

- Available at Scotland and LA level
- Available 2007/08 2018/19
