2. Progress and Results

All project activities are ahead of schedule and visits by the Scottish Government International development team have acted as a catalyst for the project. Specifically, engagement with the government of Zambia has been easier since the ministerial visit made headlines locally.

For example, our milestone for meeting with Zambian government officials in year one was to meet with **three** senior representatives (District Director level or higher). In fact, the total number cooperating on this project now stands at **37** including national leaders.

This is despite the lead the Scottish government has taken by refusing "per diem" payments as part of grant-funded projects. This has meant government participation has been on the basis of merit, and how well the project helps to achieve the government's own local and national objectives, rather than any perceived financial gain.

We have also benefited from strong policy coherence in Scotland, as the development of an income generation programme in Zambia has been helped thanks to investment from Scottish Enterprise – adding value to the funding provided from the International Development team.

As a smaller organisation, we still have a lot to learn but our progress has been encouraging and we hope to continue this momentum into year 2.

We have piloted first aid courses in Central Province and Lusaka, adapting our content to reflect the needs of the local communities.

Following meetings with the Vice President's office, we have provided training to **72 women** from the Women's Highway Market Initiative in Chibombo district and will continue to support their efforts by setting up a long term first aid team at this very dangerous stretch of road.

We have installed solar systems at three rural clinics providing light and equipment to health

centres which had previously had very high mortality rates due to lack of access to reliable electricity.

We set up a social enterprise, which has already generated over \$1500 in revenue and will grow to support the continuation of this project beyond the end of this grant.

Finally, we have embedded the First Aid Africa partnership within Zambian society, meeting with nearly 100 stakeholders over the past six months, creating new connections which will increase the capacity of our partners and our team back home in Scotland.

Diaspora support from the Zambian community in Scotland will add further value to the project from year 2 as the Scotland Zambia Partnership will dovetail their work with ours thanks to a small-grant they received in 2018.

Yes. Two baseline reports were completed during the first six months of this work with input from members of the Ministry of Health as well as direct community feedback & surveys collected by an independent Zambian consultants.

While the results from these reports will constitute our initial baseline, we will continue to develop our impact reporting to most accurately reflect our own work and the work of other stakeholders towards our wider impact indicators.

There have been no significant delays to this project and we are ahead of schedule entering year 2.

Yes, we went through an open & comprehensive recruitment process which saw 284 people apply for 2 roles in Zambia. The shortlisting process was undertaken by Challenges Global Zambia (CGZ).

3.2 Are all partnerships on the project now in place? Please update on how these partnerships are progressing, letting us know about any highlights, challenges or changes to roles and responsibilities. (Max 300 words)

Yes, we continue to work with Titandizane cooperative to help coordinate our community work in Chibombo.

New partners include First Aid Africa Zambia, and Challenges Global Zambia, who came on board to replace outgoing partner Biolife Energy Zambia (BEZ), when they could not provide the due diligence documents requested during preproject engagement.

We met with over 50 stakeholder organisations over the past six months and highlights include meetings with Virtual Doctors, the Ministry of Health, Friends of Chitambo, and the embassies of Canada and Finland - as well as attending meetings arranged by Scottish Government with other grant recipients. This led to some additional partnerships to add value to organisations such as SCIAF, through the provision of First Aid training to their Zambian partners under parallel Scottish Government funded initiatives.

4. Financial Information

The total grant offered in year 1 was £123,905

The total amount spent was £99,133.04

The majority of the difference in these two numbers is delayed spend for our extension work (funds received in March) in Chitambo district.

While we overspent in some areas, we underspent in others. We have provided a full breakdown of this as part of our financial reporting spreadsheet.

The three specific areas to be highlighted are,

£2400 Underspend on a Motorbike - Looking at the terrain in the region we're working in during the rainy season, we didn't believe the motorbike originally requested would be safe. Therefore, there is a £2400 underspend here, and an overspend of £1,539.72 in vehicle hire under "national travel" in the T&S page of the spreadsheet. A longer-term solution for this issue is under discussion with SG.

£1,101.25 Overspend in hotel accommodation over the course of the first year. This is broken down into £700 in overspend due to the fact that we underestimated how long it would take to arrange contracts for our long-term partner accommodation, and £400 in additional spending during guest visits from international visitors. This is isolated to Y1 will not be an issue in future years, as noted in the budget report.

£ 3,114 Underspend in Project Administrator costs in Scotland as we were unable to recruit someone for a short contract on such a part time basis. We have requested that our total "Actual underspend" for the year £3022, is reprofiled to enable us to complete the work of a project administrator in year 2 instead.

The business case for this is that the work still needs to be done, and combining the £3022 with the existing allocated funds for year 2, will allow us, as a small organisation to boost our capacity by recruiting a part time staff member to build reporting systems. This would be a one-off requirement in year 2, with no further impact on spending for the remainder of the grant.

5. Any other Information

As a comparatively small organisation, we have enjoyed a steep learning curve over the last six months. Despite this challenge, and the fact that we set ambitious milestone targets for year 1, we are well ahead of schedule as we enter year 2.

We would particularly like to highlight the work of Corra, who helped to critique our application in the early stages, and the Scottish Government international development team who took an active interest in our work, visiting our project sites in Lusaka and Central Province.

The project contributes to 7 of the 17 UN Sustainable Development Goals in Scotland and Zambia, and a separate overview of this contribution is included for impact reporting purposes.

Finally, we should note the hard work of the Zambian Government's Ministry of Health in supporting this project. From District Health Directors, to Provincial Level officials and the National coordinator for Emergency Medicine, they have consistently articulated the local need and collaborated efficiently with us and other civil society partners on developing initiatives which truly serve the population from urban Lusaka to rural Chitambo.

Thanks to their dedication, we've been able to bring together the first aid community in Zambia, and connect with the African Federation of Emergency Medicine (AFEM) to reach consensus around a protocol to standardised training of lay responders in low resource communities.

This will contribute to Pan-African discussion in pre-hospital healthcare at a conference in Rwanda later this year, which First Aid Africa colleagues from Zambia and Scotland will be attending.
