Yes ⊠ No □ Socioeconomic Assessment: Comments Currently there is an imbalance between larger businesses, which seem to have both the ear and the financial backing of Edinburgh, and smaller businesses and individuals. The latter group often have to negotiate a minefield of seemingly conflicting stakeholders, government agencies and designations alone. An MPA would give the smaller stakeholders a voice, and force some of the less scrupulous stakeholders to abide by some universal principles. I believe there would be a considerable social benefit to an MPA, in terms of both economic gain and a wider cultural acknowledgment of the importance of the marine environment. It is crazy that the laws, regulations and initiatives that are so stringent and so numerous on land in Wester Ross have no equivalent in the surrounding waters. We need to start to promote the waters around the sensational Wester Ross landscape as keenly as we do the land, to tourists, to local people and to responsible businesses.
