The following form is to be used:

by the RMO, in hospital, where a patient who is subject to a compulsory treatment order, interim compulsory treatment order, or compulsion order that does not authorise the detention in hospital, has failed to comply with the measure(s) authorised by that order and has been conveyed to hospital under section 113.

This form is for the RMO to record the time that the patient arrived in hospital (and their detention under section 113 commenced), and that the medical examination that is required under section 113(6) has been undertaken.

There is no statutory requirement that you use this form but you are strongly recommended to do so. This form draws attention to some procedural requirements under the Mental Health (Care and Treatment) (Scotland) Act 2003. Failure to observe procedural requirements may result in authority for the patient's detention being challengeable.
