# Public Sector Employment in Scotland Statistics for 4th Quarter 2020

# **About this publication**

The statistics in this release are based on administrative records and surveys of individual public sector bodies carried out by the Scottish Government and the Office for National Statistics (ONS). This is a snapshot of employment as at December 2020, therefore the data relates to employment during the impacts of the COVID-19 pandemic in Scotland. The publication includes information on public sector employment in Scotland with distinctions made for employment in devolved bodies and reserved bodies (located in Scotland). The public sector is defined based on UK National Accounts definitions. The statistics in this release were designated National Statistics in December 2009.



Over the year, the devolved public sector headcount increased and reserved public sector headcount decreased.

Devolved public corporations saw the largest percentage increase (59.6%), while reserved other public sector saw the largest percentage decrease (-9.3%).

# **Summary**

## Key points (based on headcount data) include:

- In December 2020, there were 573,200 people employed in the public sector in Scotland, accounting for 21.8% of total employment.
- In December 2020, employment in the public sector was 11,970 more than in December 2019.
- When major reclassifications are excluded, the public sector increased between December 2019 and December 2020 by around 9,000 (1.6%)<sup>1</sup>.
- Of the total 573,200 people employed in the public sector in Scotland, 518,700 (90.5%) were employed in the devolved public sector in December 2020, 13,690 (2.7%) more than in December 2019.
- Between December 2019 and December 2020, employment in the devolved public sector increased in the NHS by 6,670 (4.0%), in Public Corporations by 5,040 (59.6%), in the Civil Service by 960 (4.7%), in Local Government by 2,100 (0.8%) and in Police and Fire Related Services by 100 (0.4%). Employment in the devolved public sector decreased in Further Education Colleges by -850 (-6.0%) and Other Public Bodies by -330 (-2.1%).
- In December 2020, 54,600 (9.5%) people in the public sector were employed in the reserved public sector in Scotland, 1,720 (3.1%) less than in December 2019.
- Between December 2019 and December 2020, employment within the reserved public sector increased in the Armed Forces by 130 (1.3%) and in the Civil Service by 230 (0.9%), and decreased in Other Public Sector by -2,080 (-9.3%).

# **About this publication**

# **Major Reclassifications**

The estimates of public and private sector employment published in this quarter's release have been impacted by the reclassification of Train Operating Companies operating under Emergency Measure Agreements, which were included in the private sector until March 2020. Having been reclassified to the public sector on 1 April 2020, they are included in estimates of public sector employment from Q2 2020 onwards. This reclassification is split across the reserved and devolved public sector.

# **Background Notes**

Statistics prior to Q1 2008 are estimates. These have been calculated using the total UK reserved public sector employment figure and applying to Scotland on a pro-rata basis as regional level data has only been collected from Q1 2008 onwards.

# 1. Total Employment and Public and Private Sector Employment in Scotland; Headcount


## (see Table 1)

Public sector employment increased by 11,970 (up 2.1%) between December 2019 and December 2020, while private sector employment decreased (down 0.9%). This increase in public sector employment is due to an increase in the devolved public sector.

The public sector is defined according to the UK National Accounts Classifications Guide


Figure 1: Public and Private Sector Employment in Scotland as at December 2020

Figure 1 provides a summary of total employment in Scotland by public and private sector.

**IMPORTANT NOTE**: Estimates for private sector employment are based on the Labour Force Survey. Labour Force Survey (LFS) responses are weighted to official population projections. As the current projections are 2018-based they are based on demographic trends that pre-date the COVID-19 pandemic. ONS are analysing the population totals used in the weighting process and may make adjustments if appropriate. Rates published from the LFS remain robust; however, levels and changes in levels (for 2020) should be used with caution.

Chart 1 shows that the number of people employed in the public sector remained relatively constant between Q1 2014 and Q2 2018, before falling in Q3 2018 and rising again from Q4 2018 onwards. Excluding the effects of major reclassifications<sup>2</sup> (i.e. taking out the headcounts for all large organisations listed in footnote 2 from the overall numbers), the number of people employed in the public sector gradually reached a peak in Q2 2006, decreased to Q3 2013 and remained relatively constant until Q3 2018. The increase between Q3 2018 and Q4 2018 is mainly due to Cordia services moving back under Glasgow City Council services and the series has continued to rise from Q4 2018 onwards.



Chart 2 shows the annual change in employment for the public sector increased by 11,970 between Q4 2019 and Q4 2020, driven by increases in the devolved public sector headcount. The devolved public sector headcount has risen due to increases in the NHS, public corporations, local government and the devolved Civil Service.

The annual change in Chart 2 for Q2, Q3 and Q4 2020 shows the effect of the inclusion of several Train Operating Companies (TOCs) within the public sector as at 1<sup>st</sup> April 2020.


#### Impact of Excluding Major Reclassifications from Public Sector

If the major reclassifications<sup>2</sup> were to be excluded from the public sector series (i.e. the headcounts for all large organisations listed in footnote 2 were taken out of the overall numbers), there would be around 555,000 people employed in the public sector in December 2020. This was 21.1% of the total employment in Scotland compared with 21.8% if major reclassifications are included.

Public sector employment, excluding the effects of the major reclassifications, would be around 9,000 (1.6%) higher in December 2020 compared with December 2019.

Chart 3 below shows that the overall public sector in Scotland increased by 11,970 (2.1%) between December 2019 and December 2020. Chart 3 also shows the estimated impact of removing major reclassifications from the series.


# 2. Public Sector Employment by Devolved and Reserved Responsibility; Headcount

(see Tables 2, 3 and 4)

The devolved public sector headcount was 2.7% higher and the reserved public sector was 3.1% lower as at December 2020 compared with December 2019. Public Corporations saw the largest percentage increase (59.6%) in the Devolved public sector, while Further Education Colleges had the largest decrease (-6.0%). In the Reserved public sector, Other Public Sector had the largest decrease (-9.3%) and the Armed Forces had the largest increase (1.3%) compared to December 2019.

The devolved public sector covers those bodies which are the responsibility of the Scottish Government or Scottish Parliament while the reserved public sector in Scotland covers those bodies for which the UK Government has ministerial responsibility.

# 3. Devolved Public Sector Employment in Scotland; Headcount

## (see Table 3)

Employment in the devolved public sector was 13,690 (2.7%) higher at 518,700 in December 2020 compared with 505,000 in December 2019.

The devolved public sector includes:

Devolved Civil Service (see section 5),

Local Government, covering Scottish Local Authorities, Police and Fire Services (up to Q1 2013), Valuation Joint Boards and Regional Transport Partnerships,

Police and Fire Services (Q2 2013 onwards),

NHS in Scotland,


Further Education Colleges,

Devolved Public Corporations,

Other Devolved Public Bodies (which covers Non-Departmental Bodies and other bodies).

The increase over the year in the overall devolved public sector headcount was due to:

- Employment levels in the NHS increasing by 6,670 (4.0%) to 172,600 in December 2020<sup>4</sup>;
- Employment in Public Corporations increasing by 5,040 (59.6%) to 14,000 in December 2020;
- Employment in the Devolved Civil Service increasing by 960 (4.7%) to 21,600 in December 2020;



- Employment in Scottish Local Government increasing by 2,100 (0.8%) to 254,000 in December 2020;
- Employment in the Police and Fire Services increasing by 100 (0.4%) to 28,200 in December 2020;

#### while:

- Employment in Further Education Colleges fell by -850 (-6.0%) to 13,400 in December 2020;
- Employment in Other Public Bodies fell by -330 (-2.1%) to 15,600 in December 2020.

# 4. Reserved Public Sector Employment in Scotland; Headcount

## (see Table 4)


The number of people employed in the reserved public sector in December 2020 was 54,600, which is 1,720 (3.1%) lower than in December 2019.

The reserved public sector employment includes:

- Reserved Civil Service (see section 5);
- Armed Forces;
- Other Public Sector (which covers Public Sector Financial Institutions, Non-Departmental Bodies and Other Bodies).

Chart 5 shows the size of each group in the reserved public sector as at December 2020.


The decrease over the year in the overall reserved public sector headcount was due to:

 Employment levels for Other Public Sector<sup>5</sup> falling by -2,080 (-9.3%) from 22,300 in December 2019 to 20,200 in December 2020;

#### while:

- Employment levels for the Reserved Civil Service increased by 230 (0.9%) to 24,600;
- Employment levels for the Armed Forces increased by 130 (1.3%) to 9,800.

# 5. Civil Service Employment in Scotland; Headcount

(see Tables 5 and 6)

This section provides a summary of the civil service in Scotland.

In December 2020, there were 46,100 people employed as civil servants in Scotland. This is made up of 21,600 (46.8%) people working in the Devolved Civil Service and 24,600 (53.2%) working in UK government departments. The total number of civil servants has increased by 1,190 (2.6%) between December 2019 and December 2020.

#### The **devolved civil service** is made up of:

- Scottish Government Core Departments
- Scottish Government Agencies
- Crown Office and Procurator Fiscal Service
- Non-Ministerial Departments

### The **reserved civil service** is made up of:


- UK Government Departments
- Scotland Office

### **Devolved Civil Service**

The Devolved Civil Service has 960 (4.7%) more people employed in December 2020 than in December 2019.

Chart 6 shows a breakdown of the Devolved Civil Service in Scotland as of December 2020<sup>6</sup>.

#### **Scottish Government Core**

In December 2020, there were 7,600 people employed in Scottish Government (SG) Core Directorates, which is 35.2% of the devolved civil service in Scotland. Employment in SG Core Directorates was 460 (6.4%) higher in December 2020, compared with December 2019.

## Scottish Government Agencies<sup>7</sup>

There were 8,300 people employed in Scottish Government Agencies in December 2020. Employment in SG Agencies increased by 420 (5.4%) compared with December 2019.

### **Non Ministerial Departments**

Non Ministerial Departments (NMD) include National Records of Scotland, Registers of Scotland, Office of the Scottish Charity Regulator, Scottish Courts and Tribunals Service, Scottish Housing Regulator (from April 2012), Revenue Scotland (from January 2015), Food Standards Scotland (from April 2015) and Scottish Fiscal Commission (from September 2017). In December 2020, there were 3,800 people employed in these NMDs. This was 50 (1.3%) more than in December 2019.

#### **Crown Office & Procurator Fiscal**

In December 2020, there were 2,000 people employed in the Crown Office & Procurator Fiscal, an increase of 30 (1.7%) since December 2019.



### **Reserved Civil Service**

Employment in the Reserved Civil Service was 230 (0.9%) higher than in December 2019, increasing from 24,300 in December 2019 to 24,600 in December 2020.

## **Department for Work and Pensions**

In December 2020, there were 8,600 people employed in the Department for Work and Pensions (DWP). Employment in DWP was 330 (3.9%) higher in December 2020 compared with December 2019.

#### **HM Revenue and Customs**

There were 7,700 people employed in HM Revenue and Customs in December 2020, 400 (-5.0%) fewer than December 2019.

#### **Ministry of Defence**

There were 4,100 people employed in the Ministry of Defence in December 2020, the same as in December 2019.

## Other Civil Service8

The number of people employed in Other Reserved Civil Service in December 2020 was 3,000, 270 (9.7%) higher than December 2019.

### **Department for International Development**

The number of people employed in the Department for International Development in December 2020 was 1,000, 40 (3.7%) higher than December 2019.

#### **Scotland Office**

In December 2020, there were 90 people employed in the Scotland Office, the

same as in December 2019.

Other Civil Service includes Home Office, Ministry of Justice, Department for Transport, Food Standards Agency (until 31 March 2015), Department for Environment, Food and Rural Affairs, Business, Energy and Industrial Strategy, Chancellor's Other Departments, Department for International Trade, HM Treasury, Office of Gas and Electricity Markets, Office of Rail and Road, UK Export Finance, UK Statistics Authority, Cabinet Office and Driver and Vehicles Standards Agency.
