COVID-19 BUSINESS SUPPORT EXPERIMENTAL STATISTICS: STRATEGIC FRAMEWORK BUSINESS FUND AND OTHER LOCAL AUTHORITY SUPPORT SCHEMES (DATA AS 25 JUNE)

This publication provides experimental statistics for the Strategic Framework Business Fund (SFBF), which was set up to support businesses in Scotland required by law to close or to significantly change their operations due to direct COVID-19 restrictions. The Fund was opened on 2 November 2020 and provided support through a temporary closure grant or a business restrictions grant (see introduction section for more details). This publication provides information on these funds cumulatively from their introduction on 2 November 2020, to 22 March 2021. It also provides information on the one-off Restart Grant and transitional payments paid on 19 April 2021 and the Localised Restrictions Support Fund paid since 17 May 2021.

Additionally, this publication provides information on other support funds administered by Local Authorities across Scotland since November 2020 at their introduction up to the 25 June (see introduction section for details). Information is available for payments made under the following schemes:

- Hospitality, Retail and Leisure Top Up grant;
- Island Equivalent Payments and Top Up;
- Local Authority Discretionary Fund and Top Up;
- Taxi and Private Hire Driver Support Fund;
- Contingency Plus: Travel Agents;

As at 25 June 2021 **a grand total of £1,226,877,995** has been paid out from the Strategic Framework Business Fund, Restart Grant and Transitional Payments and other business support schemes administered by local authorities since November 2020 (see **Table 1**).

£344,783,237 has been paid out to 47,658 premises under the **Strategic Framework Business Fund** (SFBF) **business restrictions and closure grants** (2 November 2020 to 22 March 2021, at scheme close). At the national level:

- 69% of the 69,150 premises applying for SFBF were accepted. 30% of applications were rejected, and 1% were either referred or deferred¹. The remaining less than 1% were still awaiting processing.
- 92% of funds were paid out under the temporary closure fund with the remaining 8% paid out under the business restrictions fund.
- 89% of funds were paid to businesses with rateable value less than £51,000, the remaining 11% being paid to larger businesses.

The maximum amount forecast for SFBF payments for the period from 2 November 2020 to the 22 March (at scheme close) was £419,570,000 (assigned pro rata for the period²). Of this amount, £344,783,237 (82%) of the forecasted spend has been disbursed to 47,658 business premises.

Alongside the SFBF as at 25 June 2021:

- A total of £238,539,500 has been paid out to 33,681 premises under the Hospitality, Retail and Leisure Top Up funds
- Under the **Island Equivalent Payments (IEP)** scheme £8,644,700 has been paid to 1,660 premises. An additional £4,068,000 has been paid to 605 premises through the IEP top ups, for a total payment of £12,712,700.

The **Restart Grant and Transitional Payments** paid out £431,976,593 in Restart grants and transitional payments to premises already in receipt of SFBF or IEP payments. In addition Small Accommodation Providers that Pay Council Tax received £12,844,000 in Restart grants and transitional payments. Together this totals £444,820,593.

The **Localised Restrictions Fund** has paid £388,600 to businesses in Moray and £2,308,275 to businesses in Glasgow under level 3 restrictions from 17 May. For the 14 local authorities under level 2 restrictions from 5 June the fund paid a total of £6,603,200 to 6,367 premises. Together this totals £9,300,075 to 9,038 premises.

¹ Referral or deferral can occur for a variety of reasons and refers to applications that have been passed to a different processing body or have been set aside pending resolution of an issue that goes beyond normal processing.

² This is using an 'indicative allocation' for the period 28 December 2020 to 22 March 2021 which would have been the amount that would have allocated the 4 week cycle of payments had been kept. This allows a comparator percentage of payments made to date in line with previous publications.

Other local authority administered business support schemes, as at 25 June 2021:

Under the **Local Authority Discretionary** fund £92,394,065 has been paid to 22,902 premises. Of the 29,696 premises applying; 77% have been accepted, 22% rejected, referred or deferred, and 1% are still to be processed. An additional top up of £769,000 was allocated to Glasgow City in recognition of the localised level 3 restrictions in place in May 2021. A total of 2018 premises were supported by the top up, totalling £769,075. Together this totals £93,163,140.

Under the **Taxi and private hire driver support fund** (March 2021) a total of £32,757,500 has been paid out. This money was paid to 21,838 drivers, which accounts for 65% of the 33,767³ eligible drivers.

For the **Contingency Plus** payments a total of £5,391,250 has been paid to 345 Travel Agents, Breweries and Indoor Football Centres. The majority of these premises were Travel Agents.

The Exclusive Use and Large Self Catering Grant scheme has paid a total of £3,046,000 to 1,443 premises.

£8,830,000 has been awarded to 1,481 premises under the **Small Accommodation Providers who pay council tax scheme** (including all three waves of this fund).

The **Top Up Payments To Licensed Bingo Clubs And Casinos scheme** has paid a total of £2,850,000 to 57 premises.

Local authority administered business support schemes opened since 17 May 2021:

The **Taxi and Private Hire Driver and Operators Fund** (June 2021) has paid a total of £30,684,000 paid to 20,456 drivers. Payments to operators are being made in June/July 2021.

1. Introduction and background

1.1 Strategic Framework Business Fund

All businesses in Scotland that that are required by law to close or to directly and significantly change their operations due to COVID-19 restrictions from 2 November 2020 have been eligible to apply for grant funding available through the Scottish Government's Strategic Framework Business Fund (SFBF). This fund is now closed for applications. The SFBF was administered by Local Authorities. A business could previously apply for a:

- Temporary closure grant of £2,000 or £3,000 (depending on rateable value⁴ for the premises from which businesses operate) if it was required to close by law; or,
- Business restrictions grant of £1,400 or £2,100 (depending on rateable value for the premises from which businesses operate) if it could remain open but was specifically required to modify its operations by law, for example having to close earlier than normal. This did not include where a demand for products or services had been reduced because of the pandemic.

Payments have been made in arrears, and the final four-weekly payment from the Strategic Framework Business Fund was made on 22 March 2021.

The support provided through the SFBF is separate from that made available to businesses through the Coronavirus (COVID-19) Restrictions Fund, which supported businesses impacted by local COVID-19 restrictions from 9 October until 1 November. Applications for that funding closed on 3 November 2020, and statistics are reported here (Coronavirus (COVID-19) - business support funding: statistics (circuit breaker) – 29 January 2021 - gov.scot (www.gov.scot))

1.2 Restart Grant and Transitional Payments

On 19 April 2021, all eligible SFBF and Island Equivalent Payment recipients automatically received a combined final **transitional payment** and one off **restart grant** to help them reopen:

Non-essential retailer businesses received a payment of £7000 (£1,000 transitional payment + £6,000 restart grant) for properties with a rateable value of below £51,000 or a payment of £7500 (£1,500 transitional payment + £6,000 restart grant) for properties with a rateable value of more than £51,000.

⁴ Rateable Value (RV) gives an indication of the size of the business premise receiving the funds and also determines the payment rate.

Hospitality and leisure businesses received a payment of £9000
 (£1,000 transitional payment + £8,000 restart grant) for properties with a rateable value of below £15,000; £13,000 (£1,000 transitional payment + £12,000 restart grant) for properties with a rateable value of between £15,000 and £51,000; or £19,500 (£1,500 transitional payment + £18,000 restart grant) for properties with a rateable value of above £51,001.

In addition to those businesses in receipt of financial support through the <u>Strategic</u> <u>Framework Business Fund</u> the **Restart Grant and Transitional Payments** were extended to those businesses that received a grant through waves 1 – 3 of the <u>Small</u> <u>Accommodation Providers Paying Council Tax Fund:</u>

all premises that received a grant award through any of the three waves
of the Small Accommodation Providers Paying Council Tax Fund
received a one-off grant of £9,000 (£1,000 SFBF equivalent payment +
£8,000 restart grant).

1.3 Localised Restrictions Fund

In recognition of the changes to dates originally set out in the Strategic Framework, the Scottish Government has provided additional support for businesses in local authorities which have been subject to restrictions for a longer period of time.

Moray Localised Restrictions Fund - For the period from 17 May, additional support was provided to specific businesses in Moray while they remained in Protection level 3. A one off grant of up to £1,500 was provided for sectors that remained closed and up to £1,050 for businesses that required to modify their operations. Hospitality and tourism businesses were also eligible for a one-off grant of up to £1,000 in recognition of the impact of travel restrictions on the council area.

Glasgow Localised Restrictions Fund - For the period from 17 May, additional support was provided to specific businesses in Glasgow for the duration they remained in Protection level 3. Up to £750 a week was provided for sectors that remained closed and up to £525 a week for businesses that required to modify their operations. Hospitality and tourism businesses were also eligible for a grant of up to £500 in recognition of the impact of travel restrictions on the council area.

The 5 June Local Restrictions Support Fund provided financial support for businesses impacted by the Scottish Government's decision on 2 June to retain Protection Level 2 restrictions in 14 Local authority areas in response to rates of COVID-19. The fund offered grants of up to £750 each week to the soft play sector that remained closed in Protection Level 2 but which was permitted to open elsewhere in Scotland from 5 June. Businesses required to modify their operations as a result of being in Protection Level 2 were provided with support of up to £525 per week.

Only businesses that previously received financial support through the Strategic Framework Business Fund were eligible for a grant through these schemes.

1.4 Hospitality, Retail and Leisure Top Up funds

The Scottish Government announced on 21st December 2020 (hospitality), 27th December 2020 (retail) and 11th January 2021 (leisure) a new package of support to help businesses in these sectors closed or impacted by protective measures. Businesses were eligible to receive one-off grants depending on the Rateable Value of the business property. To be considered eligible for the top up payment a business had to apply to the Strategic Framework Business Fund by 5 February 2020. This fund is now closed.

1.5 Island Equivalent Payments and Top Up

The island equivalent payment recognised that while islands faced a lower level of restrictions, there were significant impacts on many island businesses. For eligible businesses, this fund brought the support available to them in line with similar businesses subject to level 4 restrictions on the mainland, for January 2021 and beyond. This fund was available in Orkney, Shetland and Comhairle nan-Eilean Siar, and islands in Highland and Argyll and Bute. The eligibility criteria were the same as for the Strategic Framework Business Fund and the top up also provided an equivalent additional payment to the Hospitality, Retail and Leisure Top Up fund. This fund is now closed.

1.6 Taxi and Private Hire Driver Support Fund

Licensed taxi or private hire drivers experiencing financial challenge as a result of coronavirus (COVID-19) were eligible to receive a one-off grant of £1,500. This support is separate from and in addition to any other funding they may have received from the Scottish or UK Government, for example the Self-Employed Income Support Scheme and the COVID-19 Public Transport Mitigation Fund.

1.7 Local Authority Discretionary Fund

This fund was established to mitigate the short term financial challenges being experienced by businesses adversely impacted by restrictions and regulations introduced to control the spread of COVID-19. It enabled individual local authorities to direct additional financial support to groups, sectors or businesses within their local business communities who are experiencing immediate financial challenges as a result of current restrictions and regulations. Local authorities could use this fund at their discretion, and undertake their own assessment of need and develop eligibility criteria and application processes accordingly.

The fund was doubled from its original £30 million to £60 million, and has since been doubled again to £120 million in February 2021 to allow councils to respond further to local economic pressures.

An additional top up of £769,000 was made to Glasgow City in recognition of the localised level 3 restrictions in place in May 2021.

1.8 Contingency Plus Funds (Travel Agents, Brewers and Indoor Football Centres)

Additional funding was committed to support travel agents, brewers and indoor football centres in recognition of the specific challenges that businesses operating in these sectors experienced as a result of COVID-19 restrictions and regulations. The fund recognised that:

- travel agencies and companies that sell outbound business and leisure travel services have experienced specific challenges since the outset of the pandemic and are likely to face ongoing disruption as a result of restrictions on international travel. This fund provided a one-off grant of up to £25,000 for eligible businesses based on the Rateable Value of the premises from which they operate.
- many breweries derive a substantial portion of their income from selling beer to pubs, bars and restaurants, they have experienced a dramatic drop in sales since the outset of the pandemic due to the restrictions placed on hospitality businesses. This fund provided a one-off grant of up to £30,000 for eligible businesses based on the Rateable Value of the premises from which they operate.
- **indoor football centres** have experienced specific challenges as a result of COVID-19, due to restrictions on group exercise. This fund provided a one-off grant of up to £25,000 for eligible businesses based on the Rateable Value of the premises from which they operate.

1.9 Exclusive Use and Large Self Catering Grant

The Scottish Government announced a new package of support (21 December 2020) for the tourist accommodation sector in recognition of the impact of restrictions on gatherings and the one household rule on self-catering accommodation:

> Exclusive use properties that provide accommodation were eligible for one off grants of £10,000, if they pay Non Domestic Rates and have been evaluated by the Scottish Assessors Association as an Exclusive Use

Venue providing overnight accommodation, either in their main building or in lodges at the property, or a combination of both.

Large Self-catering businesses were eligible if they have a property
which accommodates seven or more people for which they pay Non
Domestic Rates. The number of bed spaces will be linked to records held
by Rates Assessors. The large self-catering grant made one off payments
of £2,000 available to eligible applicants.

1.10 Small Accommodation Providers paying Council Tax Fund

The Support for Small Accommodation Providers paying Council Tax Fund (SAP-CTF) was to support small accommodation providers in Scotland that pay council tax, including B&Bs, guest houses and self-catering properties, and which have been impacted by the coronavirus (COVID-19) restrictions. This fund was delivered in the three waves. The first and second waves supported businesses that have previously been supported by either the Bed and Breakfast hardship fund or Creative, Tourism and Hospitality Hardship Fund in 2020. The third wave was for other eligible businesses who have not previously been funded by either of these schemes. Applications for the third wave went live on Monday 15 March and applications closed on Monday 22 March. The grant took the form of one £6,000 award, the equivalent of three 4-weekly payments of £2,000.

1.11 Top Up Payments To Licensed Bingo Clubs And Casinos

An additional top up was provided to licensed bingo clubs and casinos. The grant was a one off payment of £50,000 for eligible businesses. To be considered eligible for the top up payment a business had to apply to the Strategic Framework Business Fund by 22 March 2021. This fund is now closed.

1.12 Taxi and Private Hire Driver and Operators Fund

Taxi drivers that received support through the Taxi Driver and Private Hire Vehicle Driver Support Fund were eligible for an additional payment of £1,500 paid in June 2021. For eligible Taxi operators the Fund offers support of between £1,000 - £15,000 based on the number of vehicle licenses each owner/operator holds. There is no application process and councils aim to make payments in June/July 2021.

2. Strategic Framework Business Fund, and Restart Grant including Transitional payments

This section relates to business premises in receipt of Strategic Framework Business Fund (SFBF) grants and Restart Grants. **Tables 1 to 5** show information from 2 November 2020 to 19 April 2021 for the temporary closure grant and business restrictions grant. **Table 6** and **Tables 7**, **7a and 7b** show information about the transitional payment and Restart Grant.

2.1 Strategic Framework Business Fund Spend

The maximum amount forecast for SFBF payments for the period from 2 November 2020 to the 22 March (at scheme close) is £419,570,000⁵. Of this amount, £341,988,752 (82%) of the forecasted spend has so far been disbursed to businesses, based on 47,297 accepted premises.

This fund closed to applications on 22 March 2021.

2.1.1 Local Authority SFBF Spend and budget allocation (to 22 March 2021)

The majority of Local Authorities have disbursed between 60% to 100% of maximum forecast expenditure, for up to 22 March⁵. The % budget allocated for Orkney, Na h-Eileanan Siar and Shetland was lower due to the receipt of Island Equivalent funding and lower restrictions throughout the period. The % budget allocation for Scottish Borders was 124%, as the actual spend was higher than estimated.

2.1.2 Local Authority level disbursements by grant type

A total of £318,781,045 was paid under the temporary closure grant. For the business restrictions grant, a total of £26,002,192 was paid. Thus 92% of funds paid are for closures, with the remaining 8% being paid for restrictions. This reflects the nature and extent of Level 4 restrictions in place before and since 26 December 2020.

2.1.3 Local Authority Spend by Rateable Value

For smaller premises with a rateable value (RV) less than £51,000 there have been 43,338 premises paid a total of £306,795,542. For larger business with RV greater than £51,000 there have been 3,320 premises were paid a total of £37,987,695. Of the funds paid 89% were paid to smaller businesses, with the remaining 11% going to larger businesses.

2.2 SFBF Premises application status

This section describes application status or premises and it is important to recognise that the figures quoted in this section relate to applications rather than awards i.e. each premise is counted once regardless of how many repeating payments (awards) it received.

This section covers information for the payment period, from 2 November 2020 to 22 March 2021 (scheme close date). However, the table is updated with changes that happened after the scheme closed such as the resolution of previously pending applications.

There have been 69,150 premises⁶ applying for SFBF business support made to local authorities across Scotland. 47,658 (69%) of these premises have been accepted. The number of applications awaiting processing as at 25 June was 89 (less than 1%).

20,983 (30%) of premises were rejected, and 420 (1%) were either referred of deferred⁷.


The distribution of applications status varied considerably by local authority— see **Chart 1 below** or **Table 5a** in the associated tables. The majority of local authorities have processed all of their applications. South Ayrshire and South Lanarkshire are awaiting information in order to process the remaining applications. A revision to this publication will be made once these applications are processed.

2.2.1 Rejection reasons

Table 5b summarises the reasons for rejecting applications (note this is different from the number of rejected premises). Applications may be rejected for several reasons including multiple applications made by a single business, not meeting the eligibility criteria or not providing sufficient information. The most common reason was that the applicant was in an ineligible sector. An estimated 53% of applications rejected (as of 25 June) fell into this category.

2.3 Restart Grant and Transitional Payments

'Non-essential Retail' and 'Hospitality and Leisure' premises previously in receipt of SFBF or IEP⁸ were eligible for the a Restart Grant. The amount paid depended on the Sector and Rateable value (RV) of the premise (see section 1.2 for full details). Of those premises estimated to be eligible, 98% were paid. Those premises that were not paid were no longer eligible for various reasons, including where applications had been withdrawn, businesses had closed or relocated.

The non-essential retail sector was paid a total of £155,259,143, and the Hospitality and Leisure sectors were paid a total of £280,717,450.

There was no dependence on rateable value for Small Accommodations paying council tax, with all premises receiving the same amount (see section 1.2 for full details). Small accommodations paying council tax were paid a total of £12,844,000.

This gives a grand total of £444,820,593 paid out under the Restart Grants, including transitional payments.

For the smallest hospitality premises with a RV less than £15,000, there have been 18,648 premises paid a total of £167,694,950. For Premises with RV between £15,000 and £51,000 there have been 5,441 premises paid a total of £70,692,000 . For larger premises with RV greater than £51,000, a total of 2,170 premises were paid a total of £42,330,500. Of the total funds paid to this sector; 60% were paid to the smallest premises, 25% was paid to medium premise, and 15% were paid to the larger premises.

3. Local Restrictions Funds

In total £6,603,200 has been paid out businesses in the 14 local authorities that remained in Protection level 2 from 5 June (**Tables 9a and 9b**).

An additional £388,600 has been paid to Moray and £2,308,275 to Glasgow that remained in Protection level 3 (**Table 9c**).

In total this scheme has paid £9,300,075 to businesses as of 25 June 2021.

4. Hospitality, Retail and Leisure Top Up Grants

Under the 'Hospitality, Retail and Leisure Top Up Grants' scheme a total of £238,539,500 has been paid to businesses. These funds have been paid to 33,681 premises, which accounts for 96% of businesses that are estimated to be eligible for top ups.

Of the 29 eligible Local Authorities 28 have reached 95% or more of eligible premises, The Highlands is the exception to this with a payment rate of 59%. 26 Local Authorities have reached 100% of eligible businesses.

5. Island Equivalent Payments and Top Up

Under the Island Equivalent Payments (IEP) scheme £8,644,700 has been paid to 1,660 premises. An additional £4,068,000 has been paid to 605 premises through IEP top ups, for a total payment of £12,712,700 across the scheme.

Of the 2,652 premises applying for IEP 92% have been approved, 8% rejected, deferred or referred, no applications are await processing. For the IEP top up an estimated 87% of eligible premises have been paid.

6.1 March 2021 fund - Local authority level eligibility and payments

Under the 'Taxi and Private Hire Driver Support Fund' a total of £32,757,500 has been paid out to 21,838 drivers (65% of the 33,7679 eligible drivers) as of 25 June 2021. Local Authorities contacted 99% of eligible drivers to verify their eligibility for funding. 70% of all eligible drivers submitted an application for processing. A budget of £57,000,000 is available for this fund, and payments so far have used 57% of this budget.

7. Local Authority Discretionary Fund

Under the Local Authority Discretionary fund £92,394,065 has been paid to 22,902 premises. Of the 28,539 premises applying; 77% have been accepted, 22% rejected, referred or deferred, and 1% are still to be processed. 12. Methodology

12.1 Data collection

Each Local Authority in Scotland has recorded information relating to applications received for the Strategic Framework Business Fund. Local Authorities in Scotland are the owners of these data.

Scottish Government asked all Local Authorities in Scotland to provide the following information, via a standardised excel template, for publication purposes;

- Number of applications received
- Number of applications awaiting processing
- · Number of applications rejected
- Number of applications referred or deferred
- Number of applications accepted (and therefore a grant awarded)
- Value of grants awarded

Scottish Government asked that this information be provided for both grants and business sectors, and within each fund for the information to be further split by rateable value (less than/equal to £51k and over £51k). The SFBF scheme closed on 22 March 2021, so this information includes reconciliations (collected as of 25 June 2021).

We additionally collect basic summary information on several other grant schemes that are administered by the Local Authorities. Information for the following schemes is as of 25 June:

- Hospitality, Retail and Leisure Top Up grant;
- Island Equivalent Payments and Top Up;
- Local Authority Discretionary Fund and Top Up;
- Taxi and Private Hire Driver Support Fund;
- Contingency Plus: Travel Agents;
- Contingency Plus: Brewers;
- Contingency Plus: Indoor Football Centres;
- Exclusive Use and Large Self Catering Grant;
- Small Accommodation Providers paying Council Tax Fund;
- Top up Payments to Licensed Bingo Clubs and Casinos;
- Taxi and Private Hire Driver and Operators Fund.

This information is returned monthly from each of the 32 local authorities, and then collated and quality assured. Information about estimated number of eligible premises for these funds also come from this data set.

12.2 Data reporting

The information received from each Local Authority was amalgamated into a single dataset. This dataset was drawn from the templates received and aimed to create national level figures. There are some caveats to this approach;

• Total premises applying is estimated by summing together accepted, rejected, referred/deferred premises and then adding the total number of applications

pending processing to this total. This will be a slight undercount as a processing application may have more than one premise listed on it. As the number of processing applications decreases the total premises applying will tend towards the true value.

 While at this stage almost all payments have been made the data set is still not entirely finalised. There is a small number of processing applications and referred/deferred cases that are pending resolution. A revision will be issued when this data is resolved.

12.3 Data Quality

Strategic Framework Business Fund:

 Some councils have not yet finalised the fund. South Ayrshire are completing their investigation and review process. South Lanarkshire have completed the review/investigation and are in the process of making payments.

Restart Grant and Transitional Payments:

- Some councils could not provide a full account of the data. Stirling council Stirling were unable to provide information on the number of Restart Grants paid to Small Accommodation Providers Paying Council Tax
- Some premises received the SFBF transitional payments, but not the restart grants for example if a business was sold or closed between the final SFBF payment on 22 March and the transitional payment on 19 April.
- The Restart grant and transitional payments were used by some local authorities to manage over and under payments from other funds. The exact payment amounts to some businesses therefore differ from the standard grant value.
- In some local authorities more premises were paid the Restart Grant and Transitional Payments than were eligible. This is due to differences in payment dates and reporting between the top up and the SFBF. These differences should be resolved in future updates.

Taxi and Private Hire Driver and Operators Fund:

- Some councils could not provide a full account of the data for drivers at this time.
- Payments to Operators were made during June and July 2021 and will be reported on in future management information publications <u>Coronavirus</u> (COVID-19): business support funding statistics - gov.scot (www.gov.scot)

An experimental statistics publication for Scotland
